On Thursday, May 31, 2007 I was informed that the previous night, Wednesday May 30th, CSIs' Fernandes and Milstead had responded to a suicide/ homicide call; please see their reports for scene information. I was told that the homicide victims' autopsy was scheduled for May 31st.

I was informed that the male suicide victim, identified as Helder Peixoto W/M with DOB 06-22-72, had jumped from the 11th floor of The Slade building located at 1551 N. Flagler Dr. A few hours into the suicide investigation the homicide victim, identified as Amity Kozak W/F with DOB 03-11-78, was found in the bedroom of the suicide victim's house located at 252 Barcelona Rd.

I responded to the Palm Beach County Medical Examiner Office located at 3126 Gun Club Rd., at approximately 1000 hours for the autopsy and general photographs of victim Amity Kozak. The autopsy was performed by Dr. Graham under case #07-0654.I observed the victim to be wearing a black shirt, black bra, pink panties, and a pair of black capri pants. The victim's bra and shirt had been pushed up towards the victim's face, exposing her breasts. The victims' right leg had been removed from her panties and pants. The following items were collected as a result of the autopsy:

- Seven (7) pieces of miscellaneous jewelry:
 - Yellow metal with clear stones toe ring, from victim's left foot
 - Yellow metal genitalia ring
 - Pair of clear stone, stud type earrings
 - Yellow metal earring in victim's upper right ear
 - White metal with clear stones ring, on victim's right hand
 - Yellow metal with clear stone naval ring
 - Yellow and white metal ring, on victim's left hand ring finger
- One (1) blue top tube of victims blood



It was decided that the autopsy for Helder Peixoto would be completed on the following day, June 1st. I collected all the items for victim Kozak and returned to the police station.

On Friday, June 1st, 2007 at approximately 1000 hours I again responded to the Palm Beach County Medical Examiner Office located at 3126 Gun Club Rd. for the autopsy and general photographs of decedent/suspect Helder Peixoto. The autopsy was performed by Dr. Graham under case # 07-0653. The decedent/suspect was wearing a shirt, shorts and shoes. The following items were collected as a result of the autopsy:

- One (1) blue top tube of the decedent/suspects blood
- One (1) Sexual Battery Evidence Collection Kit
- Two (2) envelopes of fingernail clippings from the decedent/suspects right and left hands
- Six (6) hair standards from the decedent/suspect
 - Front
 - Back
 - Left
 - Right
 - Vertex
 - Pubic
- One (1) pair of blue "Champion" shorts, size XL
- One (1) blue "Cherokee" shirt, size XXL
- One (1) pair of white "Ralph Lauren Polo" shoes (with possible blood)
- Two (2) white sheets



On Saturday, June 02, 2007 at approximately 1500 hours, I compared the rolled impressions of the male decedent obtained from the Medical Examiner's Office to the rolled impressions obtained through Detective Gellin from Detective Robert Pavia with the Boston Transit Police Department.

I first evaluated the impressions, and then compared the class characteristic of each finger. I then examined the ridge structure and Galton detail. I determined that the #2 finger, right index finger, matched on both sets of impressions, identified with 41 points of identification.

The name of the male decedent, **Helder Peixoto W/M DOB: 6/22/72**, was supplied to me by Detective Hardiman, along with a copy of the back of a lottery ticket showing Peixoto's signature. The signature on the back of the lottery ticket matched the signature on the impressions card obtained from Boston Transit Police Department.

The identification was verified in a second opinion by CSI JORUNK BRADY
