HOUSING FACILITIES, GENERAL.

In the dog rooms, and the hallway where they are turned out for exercise, there are many areas where the epoxy/paint is missing from the floor, revealing different layers of epoxy/paint, and/or exposed concrete. In the enclosures where the dogs are on the floor, there is a baseboard-like lip of a metal material that separates the floor and wall, and the epoxy/paint on its surface is in the process of coming off in nearly all rooms, and there is discoloration and evidence of deterioration. One door jam shows discoloration and rust, as does a metal support in the hallway.

Surfaces in animal areas that have missing and peeling epoxy/paint, deterioration, and corrosion cannot be adequately cleaned and disinfected. Poor sanitation could be detrimental to the health of the animals. All surfaces should be maintained in good repair on a regular basis.

HOUSING FACILITIES, GENERAL.

Food for Non-Human Primates was not stored appropriately. In a food storage area there was a bag of spaghetti that was open, with noodles protruding from the bag. There was a jar of peanut butter that had been opened in January, 2014, had passed its "best-used-by" date, was not refrigerated, and appeared to be still in use. There was a box of miscellaneous items, such as rusty chain links, blood collection supplies, a rag, an ear tag, and old padlocks, stored in an open plastic bin on the same shelf with the food.

Food for Non-Human Primates should be stored in a manner that protects it from contamination, vermin infestation, and spoilage. Failure to appropriately store food could be detrimental to the health of the animals.

To be corrected from this time forward.
