

AFFIDAVIT OF CHARLES MOSLEY III

1. I make this Affidavit based on my own personal knowledge and under the penalties of perjury. I am not presently under the influence of alcohol or any drug or substance that would impair my judgment or cognition, or the ability to tell the truth. I make this Affidavit of my own free will. Prior to making the statements in this Affidavit, I received advice from my own legal counsel, who is experienced in the entertainment industry and who is providing services for me on a pro bono basis.

2. I am presently a defendant in a lawsuit styled *Faith No More, et al. v. Manifesto Records, Inc., Evan S. Cohen, and Charles Mosley III, et al.* pending in the Superior Court of the State of California, County of Los Angeles.

3. I am a former member and lead singer of the musical group known as “Faith No More.”

4. In early 2014 (by my recollection), I entered into a contract with Manifesto Records, Inc. concerning the “Faith No More” album *We Care A Lot* (the “Manifesto Contract”). The contract was put in front of me by Evan Cohen, who has always been my lawyer. As it turns out, Evan Cohen also owned Manifesto Records, Inc.

5. I signed the Manifesto Contract because I trusted Evan Cohen. I never appreciated that Evan was not acting as my lawyer and solely with my best interests at heart when he asked me to sign the Manifesto Contract. I later learned that there was a provision in the Manifesto Contract that Evan was not acting as my lawyer, but I never read that provision. In fact, I really never read the entire contract before I signed it. Evan essentially offered me \$4,000.00 if I signed the Manifesto Contract. I desperately needed to have that money so I signed it. I did not believe I was doing anything wrong.

6. I am distraught that I am being sued by my former band members and even more distraught if I did something that would negatively impact my future relationship with the band, which I value. I consider certain members of "Faith No More" as my "family." I would never have signed the Manifesto Contract if I fully appreciated the dissention it would cause or how the band would object. I certainly would never have signed the Manifesto Contract if I knew I was going to get sued, especially by my former bandmates. I wish I would have discussed the Manifesto Contract with Roddy Bottum, who is one of the plaintiffs and a present member of "Faith No More."


7. I sincerely wish today that I never signed the Manifesto Contract. I did not fully understand what I was signing. I did not appreciate that I was apparently speaking for the band as a whole concerning the rights to certain "Faith No More" recordings. I only believed I had an equal stake in the ownership of the *We Care A Lot* album and was speaking for myself as a part owner of that album.

8. I am not saying I do not have certain rights in that album. I relied on Evan Cohen to explain my rights to me. Now I am getting sued.

9. I am reserving all rights I may have in all "Faith No More" assets that I participated in creating and by this Affidavit I am not waiving any of those rights.

10. I tried to call Evan Cohen several times after the lawsuit was filed to help me with this situation. We spoke one time. I was hoping Evan would rescind everything so we could all negotiate something with the blessing of the band. That has not happened. So I engaged another lawyer to try and help me, in particular with the lawsuit in Los Angeles. As stated above, the lawyer I engaged agreed to help me for no money; I have no money to spend on lawyers.

11. What I am saying in this Affidavit is the truth. If I am called upon to testify to the matters I am stating here, I would do that.
