Dear Mr. Routh:

The Court of Appeals affirmed the judgment of the trial court. Enclosed is copy of the Judgment and Opinion regarding your appeal for your records.

I will file a Motion for Rehearing with the Court of Appeals. If that Motion is denied you will have thirty (30) days to file a Petition for Discretionary Review (PDR), if you so desire. Simply put, a PDR is a Petition filed with the Texas Court of Criminal Appeals in Austin, Texas, which asks the Court to review the decision of the Second Court of Appeals.


As your court-appointed attorney, my representation ends with the filing of the Motion for Rehearing and I am not obligated to prepare the PDR. Generally, the Court does not appoint an attorney to prepare a PDR. I am not in a position to continue the appellate process without being compensated, so if you would like to retain me to continue the appellate process, please have someone contact my office as soon as possible. I would be happy to make financial arrangements with them. If you should have any questions, please feel free to write my office or have your family contact me.

I will send you a letter as soon as know the Court's decision regarding the Motion for Rehearing.
