JUDGEMENT, SENTENCE AND ORDER SUSPENDING SENTENCE

On March 28, 2017, this case came before the Honorable JACQUELINE FLORES, District Judge, for sentencing, the State appearing by LARISSA CALLAWAY, Assistant District Attorney, the Defendant appearing personally and by his attorneys MARK RAMSEY and TWILA HOON, and the Defendant having been convicted on March 28, 2017, pursuant to a Guilty plea, accepted and recorded by the Court, of the following offense:

1. CONSPIRACY TO COMMIT FALSE IMPRISONMENT (0129), a lesser included offense of Count 6, a fourth (4th) degree felony offense, occurring on or about the 27th day of February, 2016.

The Defendant is hereby found and adjudged guilty pursuant to North Carolina v. Alford and convicted of said crimes, and is sentenced to the custody of the Corrections Department to be imprisoned for the following terms:

Eighteen (18) Mondays as to Count 6,


Execution of the sentence is suspended and the Defendant is ordered to be placed on supervised probation for eighteen (18) months on condition that the Defendant obey all rules, regulations and orders of the Probation Authorities and observe all federal, state and city laws or ordinances. Conditions of probation shall include the following:

1. Complete any level of supervision required by Probation Authorities.
2. Abstain from alcohol and illegal drugs.
3. Submit to random drug testing.
4. Enter and successfully complete counseling as deemed appropriate by probation authorities.
5. Probation costs are waived
6. Pay \$5.00 Domestic Violence Fund Fee.
7. Provide DNA sample and pay \$100.00 DNA processing fee.
8. No contact with Jacqueline Barela.
9. Comply with the STEPS Program.
10. Other conditions: Contact with Tito Fajardo is authorized.
11. Crime Victim Reparations Fee \$75.00

The terms and conditions of probation are made terms and conditions of the suspended sentence. Defendant, if imprisoned at any time pursuant to the above conviction, shall be given credit for pre-sentence confinement of 2 days.


The Defendant shall be placed on parole for one (1) year as to Count 6 and be required to pay parole costs.

Counts 1 through 5 of CR 2016-00857 is hereby dismissed.
