The Court having received a <u>Notification of Death of Defendant-Appellant Aaron Hernandez</u> and <u>Motion to Abate Prosecution</u> from counsel for the defendant, the Court hereby enters the following <u>Order</u>:

- (1) If the Commonwealth elects to file an opposition/response to said motion, it shall do so by filing the original of said opposition/response with the Fall River Superior Court Clerk's Office, as well as by emailing a copy of said opposition/response to counsel for the defendant, and to the Assistant Clerk Magistrate assigned to Courtroom 7. - (3) The Court will conduct a hearing on this matter on Tuesday, May 9, 2017 at 10:00 am in Courtroom 7 of the Fall River Superior Court. All counsel shall appear without further notice.
