5. No promise(s), offer(s), agreement(s) or inducement(s) of any nature whatsoever have been made to Defendants by Plaintiff or its attorneys or any employee in the Office of the Attorney General of the State of New York to procure this Consent and Stipulation;

6. The annexed Consent Order and Judgment shall be entered without further notice to Defendants and shall be deemed binding upon Defendants and their administrators, executors, heirs, successors, and assigns;

7. Nothing contained in the annexed Consent Order and Judgment constitutes approval by the Attorney General of Defendants' practices, and Defendants shall not make any representation to the contrary;


8. This Consent and Stipulation may be executed in counterparts and a facsimile or PDF signature shall be deemed to be, and shall have the same force and effect as an original signature.

9. No prior request for the relief sought in this Consent and Stipulation or the accompanying Consent Order and Judgment has been made.




