#### Narrative

On Saturday 06/27/15 at 1221 hours, I was dispatched to 4661 Chariot Cir., Greenacres, FL 33463 in reference to a suspicious incident. The caller (W/F Maribel Hernandez 04/13/82) advised that she has not heard from the family in approximately 13 hours.

Upon arriving on scene, I observed one (1) W/M (Thomas R. Colon 05/13/85) and two (2) W/F's (Maribel Hernandez 04/13/82 and Victoria M. Rivera 08/17/88) standing in the driveway of the residence. All three parties appeared to be distraught over their discovery. I made contact Colon who provided the following information:

Interview- Thomas R. Colon (Contact)

Colon advised that he, Hernandez, and Rivera have not heard from their friend (W/F Elizabeth Flores 04/01/85) in about 13 hours. He stated that they came to the house to check on her, her kids, and her mother. Colon said, "We kocked on the door and no one answered. So we all walked around to the back of the house, and I decided to break the sliding glass door. When I went inside, I saw Liz's mom dead on the chair. We walked back out and called 911"

I asked Colon if anyone else walked back in after they left. He advised that no one else went back inside. I advised Colon, Hernandez, and Rivera to stand by my patrol car until other units arrive. There was no further information provided.

Upon the arrival of Sgt. Sanchez #1512 and Ofc. Pedone #1435, we proceeded towards the rear of the residence. I observed the hole in the glass door that was made by Colon. Due to most of the shattered glass still be intact, Ofc. Pedone knocked down the remaining glass for our safety. Once the sliding door was cleared, Sgt. Sanchez and I made entry into the residence after announcing our presence. Within minutes of being inside the residence, I observed a body covered by a blanket in a reclined position in the living room. I also observed a black revolver on the ground by the feet of the body. Upon turning around, I observed a child's body laying on the ground in a fetal position partially under the dining table. There was dried blood by the child and dried smeared blood by the feet of the other body.

At this point in time, we withdrew from the residence and set up crime scene within the area. I remained in the back of the residence until I was relieved by Ofc. Fuentes #1779. By this time all members CIS and SCT were notified. Once relieved, I contacted D/S Stockwell in reference to a possible child custody issued that occurred yesterday (06/26/15 PBSO Case# 15-091002). Upon speaking to D/S Stockwell, I was able to obtain the male half of the custody call (W/M Derek Allen Neff 02/24/86). I provided Sgt. Pickert #1618 with all the information that I gathered. After providing the information to Sgt. Pickert, Lt. Aultman #1401, Sgt. Sanchez, Ofc. Pedone, and I returned back into the residence to clear the residence. Once the residence was completely cleared, I posted myself by the secondary crime scene area maintaining scene security. I was later advised to transport Colon, Hernandez, and Rivera to HQ for interviews. Upon arriving at HQ, I separated all three parties in separate rooms. Until Det. Murray #1670 and Det. D'Angelo #1664 arrived at HQ. There was no further information provided.

Observations: I observed the hole that Colon made. Upon entering the residence, I observed a body that was in a reclined position covered by a blanket in the living room. I also observed a child's body laying on the ground in a fetal position partially under the dining table. There was blood by the child and dried smeared blood by the feet of the other body. There was also a black revolver on the floor by the adult body.

Actions Taken: I obtained pertinent information and provided it to the members of CIS in reference to this case.

On Saturday June27, 2015 at about 1204 hours we were dispatched to 4661 Chariot Circle, Greenacres, Palm Beach County in response to a suspicious incident call three (03) dead people.

Upon Arrival with Officer Gonzalez # 1731 and Officer Pedone # 1435, we made contact with WM Thomas R. Colon Jr, DOB 05/13/1985 FL DL C450-836-85-173-0, WF Maribel Hernandez DOB 04/13/1982, and WF Victoria M. Rivera DOB 08/17/1988. All three subjects were visibly very upset and distraught.

Mr. Colon stated that they banged on the front door; received no answer, and then he broke in the rear slider and found three dead people inside; the grandmother, daughter and granddaughter. Mr. Colon said he then ran out the front door locking the door behind him.

At this time Officer Gonzalez, Officer Pedone and I went to the rear of the residence to the rear slider the window was shattered and there was a garden hoe by the broken glass slider. The rear slider opened into the kitchen dining room area, to the right of the door was the kitchen to the left a dining room table. Through the broken window I was able to see a large area of what appeared to be dried blood on the floor by the end of the table furthest away from me. I then saw legs and feet of an adult sticking out from under a blanket in the area just beyond the dining room towards the front of the house. I saw a black revolver on the floor at the feet that was sticking out from under the blanket. I entered the house with Officer Gonzalez and announced Police. At the far end of the table NW corner of the table was a small child who appeared to be around 6 years old curled up in a puddle of blood and then the adult under the blanket. We then exited the residence. I contacted Lieutenant Aultman who was already en route, and Sergeant Pickert # 1618, the Criminal investigations Sergeant. All three witnesses on scene were then separated and asked to please not talk to each other or anyone else about what happened until the detectives talked to them. They already called friends and family members prior to our arrival. The friends and family members were beginning to show up. Officer Gilmore # 1784, Fuentes # 1779 and Riesgo #1794 arrived on scene and the crime scene was established and secured, and a crime scene log was started by Ofc Riesgo.

When Lt. Aultman arrived on scene, Lt. Aultman and I cleared the rest of the residence for officer safety. While Officers Gonzalez and Pedone cleared the back laundry room and remained in the kitchen area until our check of the home was complete. In the bedroom in the north east corner of the residence we found a WF lying in the bed in the north east corner of the room with her head towards the east and facing away from us towards the north. The female was lying in

blood bleeding from the head area. We then all exited the residence through the back sliding door.

A little bit later Mr. Colon came up to me and stated that he covered the grandmother in the living room area before exiting the residence. I then asked Mr. Colon to please explain to me again what happened.

Mr. Colon stated they came to the above mentioned residence to make contact with their friend LIZ (WF Elizabeth Flores). Mr. Colon said they were banging on the front door for about twenty (20) minutes and no one answered. He stated he knew someone should be home because both cars were in the driveway.

Mr. Colon then stated he and his girlfriend Maribel Hernandez decided to try going to the back door because the back door goes through the laundry room into the house. As Mr. Colon was trying the back door Ms. Hernandez looked through the rear sliding glass doors and yelled out "I see legs" and ran back to the front of the house. Mr. Colon stated he followed her towards the front of the house but then by the time he got to the gate on the north side of the house he decided he should try and check if the person whose legs Ms. Hernandez saw was ok. Mr. Colon Stated he went back to the rear of the residence to the sliding glass door and tried to pull the door open but it was locked. He then started looking around for something to break the glass door with. Mr. Colon stated he found the hoe and broke out the window with the hoe. Mr. Colon said he entered the residence by himself when he was about two feet inside he saw a puddle of blood on the dining room floor. He then saw grandma with the baby on her chest lying on the floor in the living room area. Mr. Colon said he then entered the front bedroom; it was dark and did not see anyone. He came out and checked the back bedroom that room was better lit and the bed was made; he stated he did not see anyone there. Mr. Colon said he entered the front bedroom again and put his hand on the bed by the window and felt a leg under the blanket. He said he pulled the blanket off the bed and saw Liz, he shook her and called her name she did not answer, she was stiff. He then grabbed the blanket put it over grandma and the baby, he stated it appeared the baby was shot in the neck area. Mr. Colon then ran out the front door locking the door behind him.

I then briefed the detectives and transported WM Roberto Reyes DOB 06/24/1965 FL DL R200-720-65-224-0 to Greenacres Headquarters 2995 S Jog RD, Greenacres, FL.

On 6/27/15 the Greenacres Police Department received a phone call transferred from PBSO at 1201 hours for 4661 Chariot Circle, Greenacres. The transferred phone call was in reference to a welfare check for the occupants of the residence. Prior to the Greenacres Road Patrol responding, Greenacres Dispatch received a phone call from friends of the family who were concerned as well, due to ongoing domestic issues.

Upon these friends responding to the home, they were unable to make contact with anyone at the front door. The friends were later identified as Victoria Rivera (8/17/88), Maribel Hernandez (4/13/82) and Thomas Colon (5/13/85). At that time, they decided to force entry to the home through the rear slider. Colon was the only one who entered the residence by using a gardening hoe to break the rear slider. Once inside the home he noticed the occupants of the residence deceased and 911 was called. Prior to exiting the home, Colon removed a blanket that was on Flores and placed it on Sheffield.

As Greenacres Police arrived on scene and cleared the residence for safety, they observed three individuals later identified as Elizabeth Flores (4/1/85), Nilda Sheffield (57-60YOA) and Sofia Chiddo (2YOA) deceased in separate rooms of the home. A firearm was located beside Sheffield in the area between the kitchen and bedroom.

I was called to respond and assist in this case investigation. I responded to Chariot Circle. Upon my arrival crime scene had been established. Several supervisors were present and along with other detectives we were all debriefed on the facts of this case. I then assisted with the scene security. I also completed a search warrant for the home (4661 Chariot Circle) with the assistance of Detective Levine. During this time it was learned that there was a fourth victim Xavier Neff (7yoa). I was then asked to visit 17468 38th Rd, Loxahatchee FL 33411 to complete a death notification with Xavier's father W/M Derek Neff. Officer Nicole Rhoads accompanied me to give the notification.

Upon our arrival we observed a small Honda SUV (FLtag#182KIV) in the driveway registered to Michelle Neff 1-17-82, 754-244-6821, Derek's wife. After sometime it was evident that no one was home. I spoke to W/M Steve Eddy of 17467 38th Rd (239-314-8717) who advised that Neff had been out during the morning mowing his lawn. He the observed Neff leave the residence with his child at approximately 1pm 6-27-15. Eddy also stated that there are 2-3 kids usually at that home. Derek is said to drive a silver Honda civic. This was also confirmed by another neighbor who refused to provide his information. Eddy also mentioned that there has been a tan church van at the home on multiple occasions.

On the way back to the scene I contacted Derek Neff on his phone, 561-460-4271. I advised him that there had been an incident at his child mother's home and he needed to respond to our agency.

At the scene again I assisted with scene security. And shortly after I was advised that Derek Neff was at the police station. Detective D'Angelo and I met with Derek and Michelle Neff and completed video recorded interviews. Derek completed a consent to search for his phone and both Michelle and Derek Neff provided there DNA samples. Upon completing the death notification both were emotionally upset and crying over having loss their son.

I returned to scene and assisted with scene security. I later assisted with completing a tow slip for one of the vehicles from the home. An evidence property for was completed for both vehicles. I then made contact with W/M Robert Hamilton the husband of Yahaira Hamilton (561-713-7007/561-317-1303). He was advised that no new information was available and upon his arrival from Washington DC he and his wife should respond to complete interviews.

On 6-28-15 I responded to the Good Samaritan Hospital where I met with Nursing Supervisor Bonnie Hafer. She confirmed that Nilda Sheffield was an EKG Technician and worked for their institution. She also advised that Nilda did work on Friday 6-26-15 and was not at work yesterday 6-27-15. She then advised that for further information we needed to speak with their public relations supervisor Ryan Liver 561-386-0721 / 561-308-9830. She also referred me to the Cardiology Director Louise Devivo 561-650-6316.

On 6-30-15 I was asked to contact W/F Sylvia Morales Scarola 11-18-65, of 126 Sparrow Drive, Apt 12B, RPB FL 33411 (561-255-7675). Derek Neff had advised that he was at her home conducting a health insurance sale appointment. Detective Levine and I visited Scarola and she confirmed all that had been stated by Derek Neff. She said that on the night of 6-26-15 he was scheduled to arrive at 7pm but he was late and arrived between 7:20-7:30pm. He had issues with his business program on his phone so he gathered her information and left about 15min later 7:45pm. She also stated that at 9:35pm he texted and emailed her the information for the insurance plan he was putting together for her sister. This time frame was consistent with the time line provided by his wife Michelle Neff. This interview was audio recorded and placed into evidence. Scarola had a business card with Derek Neff's name and photo on top of her dining room table. A familiarization photo was showed to her and she positively identified Derek Neff as the person who was in her home on the night of 6-26-15. Neff's FL DL photo was used for the familiarization.

We then responded to Derek Neff's home and collected a copy of the court custody papers for Xavier. This was turned over to Det. D'Angelo.

On Saturday 06/27/15 at 1221 hours, Greenacres Public Safety was dispatched to 4661 Chariot Circle, Greenacres, FL 33463 in reference to a suspicious incident. The caller (W/F Maribel Hernandez 04/13/82) advised that she has not heard from the family in approximately 13 hours.

The responding officer stated that upon arriving on scene, he observed one (1) W/M (Thomas R. Colon 05/13/85) and two (2) W/F's (Maribel Hernandez 04/13/82 and Victoria M. Rivera 08/17/88) standing in the driveway of the residence. All three parties appeared to be distraught over their discovery. On 06-27-15 at approximately 1230hrs, I was dispatched to the scene.

Upon my arrival, I was advised that three bodies were discovered inside the residence of 4661 Chariot Circle, Greenacres, FL 33463 by family friends W/M Thomas R. Colon 05/13/85, W/F Maribel Hernandez 04/13/82 and Victoria M. Rivera 08/17/88. It was later learned that the only person who entered the residence prior to the arrival of Greenacres Police was Thomas Colon. Through the course of the investigation, it was discovered that there was a second child unaccounted for. It was learned that Elizabeth was supposed to drop off her son Xavier with her father (W/M Derek Neff 02-24-86) the night before and that this child exchange never happened reference PBSO case number 15-091002. This prompted a secondary search of the residence in an attempt to locate the second child. Upon entering the residence, I observed that the first victim W/M Xavier Neff 01-10-08 under the kitchen table, the second victim W/F Elizabeth Flores 04-01-85 was located lying on her bed in the north east bedroom. The third victim W/F Nilda Sheffield 09-27-61 was lying on a miniature trampoline located in the living room. Nilda's body was covered up by a gray blanket. It was later learned that prior to Thomas leaving the residence, he covered her body with the blanket. After not being able to locate the second child inside the residence, I lifted the blanket that was covering Nilda and discovered that the fourth victim W/F Sofia Chiddo 03-03-13 was lying on Nilda's chest also deceased. At this point we exited the residence and began the process of obtaining a search warrant for the residence.

Upon receiving the search warrant for the residence, PBSO Crime Scene and Greenacres Crime Scene Technician Mauler began to video tape and photograph the crime scene. Upon the completion of this, I re-entered the residence in an attempt to locate possible evidence of the crime.

Upon entering the residence through the rear sliding glass door, I observed the following:

I first observed that the victim Xavier was lying under the kitchen table slumped over at the waist. Xavier head was facing south under a kitchen chair and he was wearing a blue shirt and blue/white Sonic shorts. He appeared to have a single gunshot wound to the left side of his head. It appeared to me that Xavier did not change his body position after he was shot. There was a blood trail on the floor that leads from Xavier to the rear sliding glass door. It should be noted that there was little to no blood discovered on the bottom of Xavier's feet.

I then observed a large amount of blood on the floor in the kitchen and on the side of the range as well as the living room area. The blood on the range was approximately one foot to zero inches off the floor. Inside the blood on the floor there was small (child like) foot prints observed. These footprints lead to a small pink chair in the living room. There was blood on the chair as well as the floor in front of the chair. There were also small footprints that lead from the small pink chair towards the small trampoline where Nilda and Sofia were found. It was later learned that these small footprints in the blood were left by Sofia.

I then observed an all black revolver on the floor in the living room at the feet of Nilda. This firearm appeared to be a black hammerless 38 Special. It was later discovered that there were four spent casings inside the cylinder and one live round found inside the firearm. The ammunition inside the firearm was Hornady 38 Special +P.

I then observed legs and feet sticking out from underneath a gray blanket in the living room towards the bedroom. Due to the body being covered by the blanket, I decided to wait for the M.E. Office before the blanket was removed.

There was a dresser which contained clothing next to the entrance to the hallway which leads to the bedrooms. This dresser had blood on it as well as blood on the floor in front and on the left side of the dresser. The blood on the dresser reached approximately two feet in height.

I then entered the north east bedroom where I located Elizabeth Flores. Flores was wearing a pink shirt and black shorts. She appeared to have a single gunshot wound to the back left side of her head. She was lying on her right side with her head facing east and her feet pointed to the west. She had a gray pillow between her legs. It appeared that Flores was sleeping when she was shot in the back of her head and that she did not change her body position after she was shot.

It should be noted that no other footprints other than Sofia's were located in the blood. It should also be noted that other than the rear sliding glass door being shattered, the remainder of the residence appeared secure and there were no signs of forced entry. It should also be noted that per Thomas, the residence was secured upon his arrival and that after he observed someone's legs on the floor in the living room. This caused him to shatter the rear sliding glass door to gain entry to the residence. Thomas stated that as he left the residence he exited through the front door. He stated that prior to exiting the residence; he had to unlock both locks on the front door to exit. He then stated that as he left the residence, he locked the bottom lock on the door as he left.

Upon the arrival of the Medical Examiners Office Lydia Littlefield removed the blanket covering both Nilda and Sofia. After this, I observed the following.

Nilda was lying on her back on the small trampoline which was located at the entrance of the hallway that leads to the bedrooms. Nilda's head facing north and her feet facing south and she was wearing a gray or blue shirt with black pants and she had on white/pink socks. I observed what appeared to be a single exit wound on the left side of her head (near the ear). Nilda appeared to be in a seated position when she shot herself in the head and there was a single projectile located in the drywall inside the living room approximately ten (10) feet from where she was lying. It did not appear that Nilda changed her body position after she shot herself other than falling onto her back onto the small trampoline. After Nilda shot herself, she dropped the gun at the base of her feet where it was later located. There were only a few drops of blood observed on her socks.

Sofia was found lying on her back almost in a seated position with her back against the stomach of Nilda. Sofia was wearing a pink shirt, green shorts and a diaper. Sofia appeared to have a single gunshot wound to the right side of her head with an exit wound under her left chin and then a re-entry wound at the base of her left shoulder. Sofia's head was facing the front door (east) and her feet were drooped over the side of the small trampoline towards the west. There was a lot of blood located on Sofia's feet as if she had been walking around the inside the residence through the blood. Based on the foot prints I observed in the blood, it appears that those foot prints belonged to Sofia. The evidence shows that Sofia was possibly shot in the kitchen next to Xavier and then walked over to the small pink chair where she sat down on the chair and then on the floor in front of the chair. She then got up and walked over to her dresser which was located in the living room and then back to her grandmother (Nilda) where she then climbed on her grandmother's lap and died from the blood loss. As she climbed onto Nilda, Sofia left what appeared to be footprint smudges on the wall.

Upon entering what appeared to be Nilda's bedroom (North West), I located a box of Winchester 38+P ammunition on the top of the dresser in Nilda's bedroom. The box appeared to be unopened. A receipt was later located in Nilda's purse which was later found in the kitchen on the back of a chair. The receipt shows that Nilda purchased a Ruger LCR Revolver (S/Number 541-29334) on 08-15-13 from Gander Mountain which is located at 100 Gander Way, West Palm Beach, FL 33404 reference receipt number 36743. A second receipt was later found that showed that Nilda also purchased a 20 gauge Remington Model 870 pump shotgun (S/N RS13018P) from the same Gander Mountain on 04-15-14. This shotgun was located under the dresser inside Nilda's bedroom. There were also several boxes of ammunition found under the same dresser inside Nilda's bedroom as well as a flare gun box which contained the Ruger instruction manual and a soft Ruger handgun gun bag. It should be noted that the serial number of the Ruger Revolver that Nilda purchased matched the serial number of the Ruger Revolver used to murder Elizabeth, Xavier and Sofia. It should be noted that both Nilda's and Elizabeth's vehicle/house keys were recovered inside the residence. On 06-27-15 at approximately 1426hrs, I conducted multiple interviews at the Greenacres Public Safety Complex to include the following:

# (1) Interview with W/M Thomas R. Colon 05/13/85 (561-853-4578):

Colon who is a family friend advised that on 06-26-15 he was unable to get in touch with Elizabeth on the phone so he and his wife went to her residence in an attempt to check on her. He stated that when he arrived at her residence, he

noticed that both vehicles 2012 white Chevrolet SUV FL tag 797TLR which belonged to Elizabeth and a green 2008 Nissan FL tag 387NZA which belonged to Nilda were both parked in the driveway of the residence. He stated that he, Maribel and Victoria knocked on the front door and when they got no response he forced the side gate open and entered the back yard. As he looked through the rear sliding glass door, he noticed someone's legs were in the hallway so he shattered the sliding glass door and entered the residence. As he entered the residence, he observed Nilda, Sofia and Elizabeth deceased inside the residence. Elizabeth was under a blanket on her bed which he removed and placed the blanket over Nilda and Sofia who were located in the living room. Prior to him exiting the front door he had to unlock the dead bolt and handle lock to exit the residence. He exited the residence, and locked the door handle lock behind him. Colon said the entire residence was secured/locked so he had to break the sliding glass door to gain entry to the residence. Colon stated that he was the only person to enter the residence other than the police.

Colon stated that Elizabeth and Derek had no domestic battery charges against each other as far as he knew. Elizabeth and Derek were currently fighting over custody issues for Xavier and the last job that Elizabeth had was in 2014 where she worked at the Hard Rock Casino. See recorded statement for complete interview with Colon.

# (2) Interview with W/F Victoria Rivera 08-17-88 (561-459-6925):

Victoria who is a family friend stated that she has known Elizabeth for approximately four years and on 06-26-15 at approximately 1530hrs was the last time she spoke to Elizabeth. When she could not reach Elizabeth on the phone (06-27-15) she decided to go to her residence and check on her. The first time she went to the house on 06-27-15 was at approximately 1015hrs. She knocked on her door and did not get any response from inside the residence. She then left the residence and returned a short time later (1100hrs) with Colon and Maribel. They again knocked on the front door and received no response from inside the residence. Colon and Maribel then went to the rear of the house where Colon forced entry to the residence through the rear sliding glass door and when Colon exited through the front door he stated that they were all dead. Victoria stated that after Colon exited the residence, no one else entered the residence. Victoria said that approximately two weeks ago, Derek's wife (Michelle Neff 07-14-82) slammed her car door on Elizabeth's right bicep during a child exchange in the Kholes parking lot located at Southern Blvd and Lyons Road. She believes there was a police report generated for the incident. After the incident, Elizabeth received a restraining order against Michelle which was dropped last Wednesday (06-24-15) while at the courthouse reference PBSO case number 15-086371. See recorded statement for complete interview with Victoria.

# (3) Interview with W/F Ade Griffin 10-21-76 (561-320-6006):

Ade who is Elizabeth's Attorney stated that Nilda was worried because Derek Neff 02-04-86 who is the father of Xavier had an unknown gun and Elizabeth was upset because Derek received primary custody of Xavier through the courts. She last heard from Elizabeth at approximately 1200hrs on 06-26-15 because she tried to get Derek to change the child exchange to the Greenacres Public Safety Complex instead of in the Dicks Sporting Goods parking lot which Derek refused and told her that the exchange will take place at Dicks Sporting Goods as it was set. Ade said she later received a call from David Chiddo's attorney stating that Chiddo was worried because he could not make contact with Elizabeth on her phone. She said that this was strange because Elizabeth always answers his phone calls. She then contacted Lucy and asked Lucy to have Victoria go to Elizabeth's

house to check on her. She later received a call from Victoria saying that both Nilda and Elizabeth's vehicles were parked in the driveway but they were not answering the door. Ade then called Nilda's "job" to see if she had went to work today. She was advised that Nilda worked on 06-26-15 but she was a no show on 06-27-15. She then received a call from Victoria saying that they saw someone's legs on the floor in the living room. She told them to call the police. Ade stated that Elizabeth testified earlier in court that she was in fear for her and Xavier's lives because of the child custody issues with Derek. See recorded statement for complete interview with Ade.

#### (4) Interview with W/F Maribel Hernandez 04-13-82 (561-502-8279):

Maribel who is a family friend stated that she has known Elizabeth for approximately nine to ten years. The last time she spoke to Elizabeth was on 06-26-15 at approximately 1300hrs. She was supposed to go with Elizabeth to drop off Xavier with his father (Derek) but she never received a call back from her. She attempted to call Elizabeth (561-508-0401) on 06-26-15 at approximately 1715hrs, but Elizabeth did not answer the phone. The child exchange was supposed to take place at 1800hrs in the Dicks Sporting Goods parking lot. At 1124hrs on 06-27-15, she again called Elizabeth but she did not answer her phone. Maribel said two weeks prior, Elizabeth and Michelle Neff 07-14-82 got into an argument at the child exchange. Elizabeth told her that during the argument, Michelle closed the car door on her arm which caused a large bruise. Maribel stated that she had photos of the bruises on her arm. I then asked Maribel to send me photos of the bruises which I never received. Maribel said on 06-27-15, she received a call from Victoria saying she was at Elizabeth's house and that both vehicles were there but no one answered the door. Maribel said that she began calling Elizabeth's phone on 06-27-15 at approximately 1124hrs but again Elizabeth did not answer the phone. Maribel said she and Thomas then drove to Elizabeth's house. When they arrived, she and Thomas knocked on the door but no one answered so they went around to the back yard. Maribel said when she looked through the sliding glass door, she saw Nilda lying on the floor and there was also blood on the floor. After seeing this, Thomas broke the sliding glass door and entered the residence. When Thomas exited the house, he told her "they were all gone including Sofia." Maribel stated that the only person that went inside the house was Thomas. She then went to the front of the house where she called the police. See recorded statement for complete interview with Maribel.

# (5) Interview with W/F Chelsie Smith 02-01-86 (561-859-5540):

Smith who is a family friend advised me on scene that she received a call from Elizabeth's cell phone number on 06-26-15 at approximately 1930hrs. She stated that she did not know if it was Elizabeth calling her or if someone else was using her phone because she never spoke to the person on the phone. Due to her being extremely busy she just told that caller that she could not talk and then hung up the phone.

#### (6) Interview with W/M Robert Hamilton 07-21-83 (561-713-7007):

Robert who is the brother in law of Elizabeth stated that when they saw the news release about the case being a homicide/suicide they were in disbelief because Nilda would have done anything for her kids. On 06-25-15, his wife Yahaira (Heidi) Hamilton who is the sister of Elizabeth received a couple photos from Nilda on a text message which contained photos of Sofia. This was common for Nilda to send Heidi those type of photos. The only tension between Elizabeth and Nilda was her poor choices in boyfriends. He never heard Nilda tell

Elizabeth that she should have been more like Heidi. He also stated that Nilda felt that she needed to spend more time with Elizabeth than Heidi. Nilda never told him that she felt their life was in danger. Nilda would always lock her doors while they were inside the residence. Robert stated that as far as he knows the only tension between Derek Neff 02-24-86 and Nilda were the child custody issues between Derek and Elizabeth and the fact that she felt Xavier was being mistreated while he was with Derek. Robert said there was no tension between David Chiddo 10-05-85 and Nilda as far as he could tell. During one of their visits, Nilda showed him a qun that she had recently purchased. The gun was a 38 special revolver and it was hammerless. He said when she showed it to him it was in a zippered case. Robert then showed me a journal that he found on the kitchen table inside the residence after the crime scene was released by the police. The journal was red in color and when it was found, it was in a zip lock bag. Upon viewing the first set of crime scene photos the journal was not there. After the purse was located and searched in the kitchen the journal is in the photos. Robert stated that upon reading the journal, it provided some understanding of what happened, Nilda never showed any signs of this type of behavior. See recorded statement for complete interview with Robert.

# (7) Interview with W/F Yahaira (Heidi) Hamilton 08-28-82 (561-317-1303):

On 06-29-15 at approximately 1519hrs, I conducted a recorded interview with Yahaira (Heidi) Hamilton at the Greenacres Public Safety Complex. It should be noted that Heidi is the daughter of Nilda and sister of Elizabeth. Heidi stated that on 06-27-15, she was at her house and noticed that she had several missed calls from her uncle (Robert Reyes). Upon calling him back he requested to speak to her husband (Robert Hamilton) and told him about the murders. She visits her mother at least twice a year and speaks to her a couple times a day on the phone (text/calls). It is common for Nilda to send her photos of both Xavier and Sofia. When she heard on the news that her mother (Nilda) was a suspect she did not believe it. She said that Nilda would eat peanut butter and jelly to get the children whatever they wanted. Her sister (Elizabeth) is and stopped taking her medication after Xavier was born. Nilda has had three strokes in the last four to five years and currently takes medication (high blood pressure) to prevent any other strokes as well as an over the counter sleep aid. Elizabeth never married neither Derek Neff nor David Chiddo but she was engaged to both of them at some point. Nilda liked Derek when he first started dating Elizabeth but towards the end of their relationship her relationship with Derek went downhill. The downfall of the relationship between Nilda and Derek was mostly due to the child custody issues between Elizabeth and Derek over Xavier. Her mother (Nilda) loved both the children equally. David is a great father but she does not about him being boyfriend material but he always bought Elizabeth anything that she wanted. Nilda does own a Ruger 38 Special hammerless revolver and she then showed me a photo of Nilda's gun. The gun in the photo matched the gun recovered inside the residence. Nilda was married but in 2000 Nilda and her husband (Thomas Sheffield) separated but never divorced. She received a text message from Nilda that stated how Xavier was mistreated while he was with Derek. It should be noted that we also found a similar note about Xavier being mistreated by Derek. This was collected and placed into evidence. Nilda also owned a shotgun but she does not know the make or model number. Elizabeth was the reason for Nilda and Thomas's separation because they are both alike and did not get along. Nilda always stuck up for Elizabeth and this caused issues between Nilda and Thomas. Nilda never gave any signs of depression and always appeared to be happy. After reading the journal, Heidi still can't believe that her mother (Nilda) could do what she did because she loved them so much. See recorded statement for complete interview.

### (8) Interview with W/M Roberto Reyes 06-24-65 (561-386-4370):

Roberto who is Nilda's brother stated that his daughter told him on 06-27-15 that Nilda's road was blocked off by the police. He later went to the area and when he arrived in front of her house he tried to call Nilda four to five times but she never answered the phone. He also called Elizabeth phone at the same time and she never answered. Nilda has been having issues with Elizabeth since she was born due to her being . When I asked him if he read his sisters (Nilda) journal he said Nilda just snapped. He said Nilda kept everything to herself and never talked to him about any problems she was having. Roberto also stated that he was positive that the handwriting in the journal was his sister's handwriting. He knows Nilda owned a black revolver but he does not know the make or model. Nilda told him that she bought the gun for protection because she was scared of David because he always beat up Elizabeth. She said if David came inside her house she would use the gun to protect herself. He last spoke to Nilda on 06-24-15 and Nilda appeared to be in a good mood. His daughter watched Xavier on 06-24-15 while Nilda and Elizabeth went to court. His daughter told him when they returned, both seemed upset. Nilda also told him that in the past that Xavier would always come home from Derek's house sick and hungry. See recorded statement for complete interview with Roberto.

# (9) Interview with W/M David Chiddo 10-05-85:

On 06-30-15 at approximately 1317hrs, I completed a recorded interview with David Chiddo and his attorney at the Palm Beach County Jail. It should be noted that David Chiddo is the father of Sofia and he was engaged to Elizabeth. Chiddo stated that he heard about the murders from his brother in law (Jonathan Metzger). When I asked Chiddo if there was any tension between Nilda and Elizabeth he stated there was no tension but they did argue now and then. He said Nilda would never hurt the children and he thinks the "Russians" killed them because Elizabeth testified against them two years ago. When asked if Nilda treated one child better than the other he stated that she loved both children equally. I then asked him if Nilda was a "prepper" and he stated that she did appear to stock up on survival items. He said that Nilda would take Xavier camping from time to time. I then asked him if Nilda had a gun and he stated that she told him that she was going to purchase one for protection but he never knew if she ever bought one. Liz moved back into her mother's (Nilda) house on 06-04-15 after he was arrested. Chiddo said he blames himself because Elizabeth wanted to move out of Nilda's house and he suggested to her that she stay there until after he got out of jail. See recorded statement for complete interview.

# (10) Interview with W/M Derek Neff 02-24-86:

Detective Torres and Detective D'Angelo conducted an interview with Derek who is Xaviers father at the Greenacres Public Safety Complex. Detective D'Angelo asked Derek what events happened over the last day or so. Derek explained that Friday morning he was working in Miami at his construction job. He then went to Wellington to pick up Isaiah. He then went over to Dick's Sporting Goods to conduct the scheduled child exchange with Elizabeth to pick up Xavier. Prior to arrival, Derek contacted the Palm Beach County Sheriff's Office to have a deputy stand by to prevent any incidents. Two weeks prior, on Sunday, June 14, 2015, Elizabeth attacked Michelle during the child exchange; PBSO C/N: 15-086371. While waiting at Dicks for Friday's child exchange, Derek texted Elizabeth asking where she is; however, she did not respond. I asked if a deputy or another officer went by Elizabeth's house and Derek said no. The deputy,

identified as Deputy Stockwell, documented in a report that Elizabeth did not show up for the child exchange and provided Derek with the case number; PBSO C/N:15-091002. Derek stated that Elizabeth has not shown up in the past prior to obtaining custody approximately 2 years ago in 2013. Before Derek obtained legal custody, Elizabeth kept Xavier from Derek for about 2 months. D'Angelo asked Derek to explain his whereabouts afterwards. Derek explained how he also sells insurance. Derek stated that he met with client, Sylvia Scarola, at her residence, 126 Sparrow Dr Apt. B12, Royal Palm Beach, FL 33411. Derek confirmed that he had not heard from Elizabeth since her text message at 1207 hours. He stated that this morning he woke up and cut the grass. Afterwards he and Michelle left their house at 1230 hours and drove to Wal Mart to get keys for their truck and a gift for a birthday party taking place in Plantation. Detective D'Angelo asked for consent to search Derek's phone and he agreed. D'Angelo provided him a Consent to Search Form which he read and signed. See Detective D'Angelo's supplement for complete interview with Derek Neff. Det. Torres later made contact with Sylvia Scarola, at her residence, 126 Sparrow Dr Apt. B12, Royal Palm Beach, FL 33411 and verified Derek's alibi. Please see Det. Torres's supplement for further.

## (11) Interview with W/F Michelle Neff 07-14-82:

Det. Torres and Detective D'Angelo conducted a recorded interview with Michelle who is the step mother of Xavier. Her story was consistent with Derek's. A copy of the interview was placed into evidence' please see for further.

After the interviews, Detective D'Angelo asked Mr. and Mrs. Neff for consent to collect a sample of their DNA. Both read and signed a Consent for DNA form and provided their samples. Both DNA samples were placed into evidence.

## (12) Interview with B/F Dr. Anita Wilborn:

Wilborn who is Nilda's doctor advised that Nilda only suffers from Nilda has been a patient of hers since 2014 and "in March of 2014, Nilda was given "a clean bill of health."

## (13) Interview with W/M Jared Smith and W/F Louise Devivo:

Jared and Louise who work with Nilda at Good Samaritan Hospital advised that Nilda was scheduled to work on 06-27-15 at 0700hrs. Nilda never called in sick she just never showed up for work. Nilda arrived to work on 06-26-15 and clocked out at 1500hrs due to she was not feeling well. Nilda chose Elizabeth over her husband and that lead to their separation. Nilda was very disappointed in Elizabeth's behavior. There was no way to search Nilda's work computer to see what web sites she visited. That computer is used by multiple people throughout the day.

# (14) Interview with W/M Mario Mosos 07-09-69:

Mario who works with Nilda at Good Samaritan Hospital stated that he has worked with Nilda at the hospital for several years. He and Nilda have talked in the past about how she thinks that there will be an infrastructure meltdown and that she wanted information from him about hunting and fishing. Both he and Nilda purchased their first firearm around the same time (approximately two years ago). They set several dates to go shooting together but Nilda never showed. He has never seen the gun that Nilda bought but he knows that it was a hammerless revolver through conversations they have had. Nilda started

purchasing items for camping, hunting and fishing but as far as he knows she never used the items.

#### (15) Interview with W/F Diana Ball:

Ball who works with Nilda at Good Samaritan Hospital stated that she has known Nilda for approximately six to eight months through work. Nilda never spoke about her personal life. The majority of their conversations were job related. She saw Nilda at the hospital on 06-26-15 at approximately 1500hrs. Nilda told her that she was not felling well and that she was going home. Ball said Nilda sounded congested. She offered to work for Nilda on 06-27-15 if she was unable to come to work.

# (16) Witness statement from Luz J Resto Rivera 05-31-67 (561-517-0315):

"I am a close family friend of Elizabeth Flores. I got a call from Ade worried about Elizabeth. I contact my daughter In Law (Maribel) if she spoke with Elizabeth today because she was not reply to my calls or messages so I told my Daughter Inn Law to go to there house. I was on the phone when she saw something in the door or window. Call Ade to pick me up."

## (17) Witness statement from Monica M Reyes 02-09-68 (561-386-5671):

"I am Nilda's Sister In Law. I'm here because my husband (Roberto) went by the house or the street were his sister lives with her daughter Elizabeth and her two kids Xavier and Sofia. My mother (Maria L Bell) is the owner of the house where Nilda and her daughter and her grand kids live. I was brought to the police station for questioning with my husband. My daughter Erika Reyes was babysitting from Nilda's grand kids on two separate occasions because she said she was going to court last week."

### (18) Witness statement from Maria L Bell 01-04-43:

"I rented the house to Nilda for four to five years."

#### Nilda's Journal:

1st page of Nilda's journal:

"To my daughter Heidi whom I love past infinity. I leave you with my thoughts, till we meet again. Only doing the right thing can you end the circle of life. Hard task but do able. "

"Last page of Nilda's journal:

Xavier is the sacrificial lamb. From day one I knew he came with a mission. I will free him from the hell he did not ask to be born into, and I pray to god he returns to a better world with better parents, he is worthy of it."

"When I think of the selfish act I am about to commit, my heart breaks for I be causing so much pain to others and I feel like a hypocrite because that is what I want Derek to understand the pain he has caused others".

"I hate goodbyes, so I say to all of my family that loved me, don't be sad for me. Think of me as if I was away on vacation certain to be reunited with all of you soon. It is time for my next journey, my next life. I do look forward to. Do not spend a day of sadness for this is what I want it. Xavier and I will walk together hand and hand and again I will let go of him when he is ready for his

next journey."

I'm sure that no matter how much time passes Xavier will find me again, we have eternal love. I am his Sofia and he is my Daniel."

"Heidi, I will find you also for my love for you is also eternal throughout the rest of my lifes. I will search for you. You will always be part of me and I will always keep you in my heart."

"I love you Heidi mom."

PBSO Chaplain John Argudo:

On 07-02-15, I met with Chaplain John Argudo who is currently the Chaplain for PBSO in reference to the bible and journal I recovered during my investigation. Both the bible and journal belonged to Nilda Sheffield 09-27-61. The bible was located in her personal property at Good Samaritan Hospital where she was employed as an EKG Technician. The journal was located on the kitchen table inside Nilda's residence by her son in law Robert Hamilton 07-21-83 after the scene was released to the family. It should be noted that the journal can be seen on the crime scene photos on the kitchen table. It should also be noted that both Yahaira (Heidi) Hamilton and Roberto Reyes stated that the handwriting in both the journal and bible were written by Nilda.

Upon Argudo reviewing the journal and bible he advised the following: "Unfortunately, the horrific events are due to, in my opinion continual or repetitive thoughts that were negative, unrealistic and in many ways inaccurate. She, Nilda, delved into the Christian faith as well as other religions which include teachings concerning 'reincarnation'. Due to the lack of proper spiritual guidance and insight, she was consumed into an abyss of confusion and desperation which led her to commit these acts.

Nilda owned a bible and a journal where she recorded her thought process and experiences that occurred throughout the years. She noted some scripture references that served as a reminder the 'After-life', 'Eternity.' She came up with the reasons to justify the suicide in the attempt to obtaining a 'new life.' Eternity with God is much better than her present situation, and the future 'end times' events. She was consumed with her present reality as well as events that surrounded her life which was causing her and her loved ones, much pain and unhappiness. Suicide was her answer in obtaining a new beginning, a much better life than she was experiencing. She along with her loved ones would one day be reunited and things will be so much better. In Christ, we do experience a better life and new beginning, but not by the means she chose to endure."

Vehicle said to be following Elizabeth Flores:

On 06-30-15, I received an E-Mail from Heidi which contained photos of a white vehicle that was following Elizabeth. The vehicle is a white 2009 Chevrolet bearing Florida tag 022PKW. This vehicle is registered to W/M Christopher M Dubuc 04-16-91 who resides at 8561 Winnipesaukee Way, Lake Worth, FL 33467.

Interview with W/M Christopher M Dubuc 04-16-91:

On 07-07-15, contact was made with Dubuc at his grandparent's residence (8561 Winnipesaukee Way, Lake Worth, FL 33467). Dubuc stated that he is friends with Miguel Garcia 09-018-90 who lives at 4677 Chariot Circle, Greenacres, FL 33463 and that he is at his house almost every day. Dubuc stated that he does not know Elizabeth Flores, David Chiddo or Nilda Sheffield. Contact was then made with Garcia at his residence and he confirmed that he is friends with Dubuc and that he visits him frequently. Garcia stated that he has lived at this residence for approximately one and a half years.

Tag numbers found in Nilda's vehicle:

On 07-02-15, Crime Scene Technician Mauler and I searched both Nilda and Elizabeth's vehicles. There was nothing found in Elizabeth's vehicle, but I did locate two hand written tag numbers in Nilda's center console. The tag numbers were photographed by Mauler.

The first tag is a Florida tag (117PJI) and is registered to W/M Michael A Boggs 09-27-63 who resides at 5141 Fearnley Road, Lake Worth, FL 33467. The second tag is an Alabama tag (58961P) and is registered to W/F Sharlene M Moats 08-09-54 who resides at 1556 Lake Drive BHR, Okeechobee, FL 34974.

Interview with W/M Michael A Boggs 09-27-63 (Florida tag number 117FJI):

On 07-06-15 at approximately 1700hrs, I made contact with Michael on the phone. He stated to me that the vehicle in question belongs to his daughter W/F Shannon L Boggs 11-04-95 and that she was currently at work at Simmons Vet located at the intersection of Lake Worth Road and Haverhill Road. At approximately 1715hrs, I made contact with Shannon at Simmons Vet. Shannon stated that she does not allow anyone to use her vehicle. ## AUTOPSY RESULTS AND CONCLUSIONS:

On Sunday June 28, 2015, at 0900 hours and on Monday June 29, 2015 at 0900 hours, Det. D'Angelo and I attended the autopsies of all four victims. Sheffield, Elizabeth and Xavier all died by cause of gunshot wounds to the head. Sofia's cause of death was loss of blood. Please see Medical Examiner's report for further.

Based on my above described investigation, I find that W/F Nilda Sheffield murdered her daughter (Elizabeth Flores) while she slept in her bed and then murdered both Xavier Neff and Sofia Chiddo while they were in the kitchen. Nilda then shot herself (suicide) in the head not realizing that Sofia was not dead. Sofia then wandered around the kitchen and living room before climbing on Nilda's chest where she later died from blood loss. The evidence shows that Nilda, Elizabeth and Xavier died almost immediately after being shot in the head and that Sofia died a short time later from blood loss caused by the gunshot.

Nilda's motive for the murder/suicide was outlined in the biblical verses on her bible itself which served as a reminder to her of the "After-Life", "Eternity", and in her mind were the reasons to justify her suicide, and the taking of the lives of those she loved. Nilda believed that they will be together again in another life and in a better world.

On Saturday, June 27, 2015, at around 1221 hours, Greenacres PD responded to 4661 Chariot Circle in reference to a triple homicide. At around 1230 hours, I was contacted to respond to investigate further.

At around 1316 hours, I arrived on scene. I teamed up with Det. Murray as his co-lead for the investigation. While being briefed by Lt. Aultman, Sgt. Sanchez and Sgt. Pickert, we were explained that W/F Elizabeth Flores, 4-1-85, W/F Nilda Sheffield, 9-27-61 and W/F Sofia Chiddo, 3-3-13, were deceased in the residence. Family friend and witness, W/M Thomos Colon Jr. 5-13-85, made forced entry through the rear slider upon seeing legs on the floor. When he observed everyone deceased, he grabbed the blanket off of Elizabeth and covered Sheffield who had Sofia with her. He then unlocked the front door and left while he locked it behind him. Per Colon's statements, W/M Xavier Neff, 1/10/08, was unaccounted for and unknown if he was in the residence. At that time, Lt. Aultman, Det. Murray and I went into the residence to look for Xavier. We observed Xavier deceased in the kitchen and identified all four family members.

While searching for Xavier, I observed Sheffield lying on her back on a miniature red trampoline. Her feet were facing the living room and her head the hallway towards the two bedrooms. In between her feet on the tile was a black Ruger hammerless Revolver with its barrel facing towards front door. She was covered by a brownish colored blanket. Det. Murray and I lifted the blanket, and underneath observed Sofia lying on her back against Sheffield's right side. In the living room, to the left of Mrs. Sheffield, I observed a blood trail that led to a pink "Millie" (Team Umi-Zoomi cartoon) baby couch. The seat portion was drenched in blood and there was a pool of blood on the floor in front of it. In the blood trail between the Millie couch and Nilda, there were small foot prints in both directions, to and from Mrs. Sheffield. Along the wall to the right side of the hallway, to right when you enter through the front door, I observed a small brown nightstand that was covered in blood smears. More towards the right, along the same wall, were two indentations; one of which contained a projectile. Moving forward into the kitchen, I observed small bloody hand prints along the wall and stove; these prints were from the floor to about a foot high. The hand prints were in the direction of moving from the kitchen towards the living room around the wall towards the Millie couch. In the dining area, I observed Xavier lying on the floor by the dining table. His head was underneath a dining room chair that was tucked underneath the table. There were three blood trails coming from his head that all lead towards the rear slider. There was also a small pool of smeared blood by his bottom I also saw the broken glass spread on the kitchen floor and the smashed rear slider as well. I did not observe any blood or evidence of foul play in the kitchen itself or the utility room behind it.

Next, I walked passed Sheffield and into the northeast bedroom. Here, I observed Elizabeth lying in her bed on her right side. There was a blood pool by her head. In the second bedroom, which is to the left in the hallway, I observed 20 round box of Winchester 38 Special +P ammunition. I did not observe any other evidence of foul play in this bedroom or the bathroom.

After confirming Xavier's whereabouts and observing the crime scene, Det. Murray and I went back to HQ to conduct recorded interviews with Colon Jr. W/F Maribel Hernandez, 4-13-82, and W/F Victoria Rivera, 8-17-88. During their interviews, they explained how they have not heard from Elizabeth since yesterday. Elizabeth was supposed to contact Hernandez to escort Elizabeth to Dick's Sporting Goods for Xavier's custody exchange. Hernandez did not hear from her; therefore, she tried contacting Elizabeth at around 1700 hours but never got a response. This morning they decided to go to Elizabeth's house because they still had not heard from her. Upon their arrival, they observed that Elizabeth's and Sheffield's cars were still parked in the driveway. As no one answered the door, Hernandez and Colon went around the back of the residence. Looking through the sliding glass door, Hernandez saw legs on the ground and ran away. Colon then grabbed a hoe and made forced entry through the slider into the residence. Colon stated that inside the residence, he observed Sofia and Sheffield on top of the trampoline. He then saw Elizabeth in the northeast bedroom. He had removed the blanket off of Elizabeth when he tried to identify her. Colon then grabbed that same blanket and covered Sofia and Sheffield so that no one could see them. Next, Colon unlocked the front door, to include the deadbolt, and exited the residence. Colon then relocked the bottom lock to the front door as he left so that no one could reenter the residence until the police arrived. Colon stated that he did not see Xavier inside the residence. Please see Det. Murray's supplement and the copies of the interviews for further.

During the investigation, contact was made with Derek Neff on his phone and asked to respond to the Greenacres Police Department. At around 1800 hours, he and Michelle Neff arrived at the Greenacres Police Department where Det. Torres and I conducted recorded interviews with them. During Derek's interview, I asked what events happened over the last day or so. Derek explained that Friday morning he was working in Miami at his construction job. He then went to Wellington to pick up Isaiah. He then went over to Dick's Sporting Goods to conduct the 1800 hours scheduled child exchange with Elizabeth to pick up Xavier. Prior to arrival, Derek contacted the Palm Beach County Sheriff's Office to have a deputy stand by to prevent any incidents. Two weeks prior, on Sunday, June 14, 2015, Elizabeth attacked Michelle during the child exchange; PBSO C/N:15-086371. While waiting at Dick's for Friday's child exchange, Derek texted Elizabeth asking where she is; however, she did not respond. I asked if a deputy or another officer went by Elizabeth's house and Derek said no. Derek confirmed that he and Elizabeth have a set 6pm call time and to prevent any further issues was just going to call Saturday at 6pm. The deputy, identified as Deputy Stockwell, documented in a report that Elizabeth did not show up for the child exchange and provided Derek with the case number; PBSO C/N:15-091002. Per the PBSO report, Deputy Stockwell also called Elizabeth at around 1820 hours. Elizabeth's phone went straight to voicemail; therefore, he left her a message. Derek also stated that Elizabeth has not shown up in the past prior to obtaining full custody approximately 2 years ago in 2013. Before Derek obtained legal custody, Elizabeth has kept Xavier from Derek for about a 2 months' timeframe.

After discussing the child exchange, I asked Derek to explain his

whereabouts yesterday. Derek explained how he works construction for Big T Concrete Cutting and is a health insurance salesman. Yesterday, he was working construction in Miami until around 1530 hours. At around 1700 hours, he picked up his younger son at daycare in Wellington. From there, at around 1745 hours he arrived to Dick's Sporting Goods for the child exchange. Derek stayed there with the deputy until around 1830 hours. Derek then went home to drop off his son and take a shower for his insurance sales appointment. At around 1930 hours, Derek met with client, Sylvia Scarola, at her residence, 126 Sparrow Dr Apt. B12, Royal Palm Beach, FL 33411. The meeting was brief. Derek left by 20105 hours and was home by 2030 hours. Derek then confirmed that he still had not heard from Elizabeth since her text message at 1207 hours. This morning he woke up and cut the grass. Afterwards, he and Michelle left their house at around 1230 hours and drove to Wal Mart to get keys for their truck and a gift for a birthday party taking place in Plantation. At the party he was contacted by Det. Torres; therefore he and Michelle responded here.

I asked for consent to search his phone and Derek agreed. I provided him a Consent to Search Form which he read and signed.

Det. Torres and I then conducted a recorded interview with Michelle. During our interview, Michelle stated that she has been married to Derek for about three and a half years and they have a 2 year old boy together name Isaiah. In regards to her day's timeline, Michelle explained that she dropped Isaiah off at school yesterday morning after 0800 hours. Michelle then went to work in Palm City and left work late at around 1720 hours. At around 1800 hours, while driving home, she received a call from Derek stating that Elizabeth did not show up for the child exchange at Dicks Sporting Goods. Derek also explained to her that the deputies were there and asked for a copy of the final judgment agreement between him and Elizabeth. Michelle therefore emailed it to him. Derek came home at around 1900 hours but quickly left for an insurance sales meeting. Derek came home from the meeting between 2000 and 2030 hours. During this time, Michelle got Isaiah ready for bed. Derek and Michelle then watched TV together and went to bed between 2200 and 2230 hours. This morning, Isaiah woke up this morning at around 0630 hours. Michelle tended to Isaiah while Derek cut the grass. They all then left the house at around 1215 hours to leave for a birthday party in Broward; however, they had to go get keys for his new truck and pick up the birthday present first. They then arrived at the party at around 1415 hours. At the party, they received the call from the police. In regards to dealings with Elizabeth, Michelle's story was consistent with Derek's to include child custody issues and past physical altercations. Besides these incidents that occurred during the child exchanges or custody battles, neither Elizabeth nor Sheffield ever reached out to or contacted Michelle. In addition, Michelle stated that she has never contacted them. Michelle stated that prior court orders, she and Derek would pick up Xavier at Sheffield's house but that stopped once the court orders were finalized. Last, all communication would be with Derek and documented through text messages or emails. A copy of the interview was placed into evidence' please see for further.

After their interviews, I asked Derek and Michelle for consent to collect a sample of their DNA. Both read and signed a Consent for DNA form and provided their DNA samples. Both DNA samples were placed into evidence.

At a later date and time, Det. Torres made contact with Sylvia Scarola, at her residence, 126 Sparrow Dr Apt. B12, Royal Palm Beach, FL 33411 and verified Derek's alibi. In addition, Det. Torres made contact with Derek's neighbors who confirmed that Derek was seen cutting the grass this morning.

Please see Det. Torres's supplement for further.

During this time, a search warrant was obtained for the residence. PBSO Crime Scene Technicians, Greenacres Crime Scene Technician Mauler, Det. Murray and I executed the search warrant. Inside, I observed that the revolver was identified as a Ruger LCR, S/N: 54129334. It had a 5 shot cylinder that contained 4 spent casings and 1 live round; all of which were Hornady 38 Special +P rounds. Upon searching the northwest bedroom which I believed to be Sheffield's, I observed an unopened box of Winchester 38+P ammunition on top of the dresser. Behind a small TV on the dresser, I located an unopened box of Remington eye and ear protection. In the open space underneath the bottom drawers of the dresser, I located a Remington shotgun, serial number: RS13018P, several more boxes of ammunition, shot gun shells, a black plastic handgun case and a soft Ruger handgun case. In order for me to find these items, I had to completely remove the two bottom drawers from the dresser to find these items. I then had to unscrew the rail on the left side in order to remove the shotgun.

Next, in the bathroom closet, 3 different medications prescribed to Sheffield by Dr. Anita Wilborn were located. They were:

- In a later interview with Dr. Wilborn, she confirmed that the was for and chest tightness, the was a sleep aid and the was for none of which were known to have negative side effects such as suicidal or homicidal tendencies.

On Sunday June 28, 2015, at 0900 hours and on Monday June 29, 2015 at 0900 hours, Det. Murray and I attended the autopsies of all four victims. Sheffield, Elizabeth and Xavier all died by cause of gunshot wounds to the head. Sofia's cause of death was due to a loss of blood. Please see the Medical Examiner's report for further.

Monday afternoon, at around 1400 hours, Det. Murray and I met Elizabeth's sister, W/F Yahaira "Heidi" Hamilton, and her husband Major Robert Hamilton, at the Greenacres Police Department. During recorded interviews, both could not believe Sheffield was capable of conducting something like this as she loved her children and grandchildren. They were both unaware of any serious issues within the family except for Sheffield's concerns with Elizabeth's custody battle over Xavier. During the interview with Major Hamilton, he provided us with a red journal secured in a zip-lock bag that he located on the kitchen table. On the inside cover, Sheffield wrote a note to Yahaira that stated, "I leave you with my thoughts. Till we meet again. Only doing the right thing can you end the circle of life. Hard task, but do-able." There were many other scriptures in reference to Xavier being a sacrificial lamb, to the bible and to what I inferred to be retaliation to the pain Derek caused Sheffield and her family. Copies of the interviews were placed into evidence along with the journal; please see for further.

On Tuesday, June 30, 2015, at around 0900 hours, Det. Murray and I conducted a recorded interview with Sheffield's brother, W/M Roberto Reyes, 6-24-65. Mr. Reyes explained that he had not seen or spoken to his sister since last Saturday. His daughter, Erica, babysat Xavier and Sofia this past Wednesday when Sheffield and Elizabeth were in court. When they arrived home after court,

Sheffield and Elizabeth were allegedly upset and asked Erica to walk home. Last, Reyes explained that he read the journal and identified it as his sister's handwriting. He went on to say that he never knew she had thoughts like this; she never told anyone.

On Tuesday, June 30, 2015, at around 1317 hours, Det. Murray and I made contact with David Chiddo and his attorney, Flynn Bertisch, at the Palm Beach County Jail. Chiddo initially believed that the incident to have been caused by the "Russians" relating to an incident involving Elizabeth between 2009 and 2013. He then explained that he never would have thought Sheffield would have done this. She loved her kids and grandkids. When asked about family life, Chiddo stated that Elizabeth moved into her mother's residence when he was arrested on June 4, 2015. He advised that through the years they were together, there was plenty of family bickering between Elizabeth and Sheffield; however, none of it appeared excessive or out of the ordinary. Chiddo was also aware that Sheffield stocked up on a lot of "stuff" and would go camping with Xavier. Chiddo was also aware that Sheffield wanted a gun for general protection. Last, Chiddo gave us consent and the password his laptop that we located in Elizabeth's room and provided his password. He also stated that there should be another orange HP laptop and a silver Macbook with a purple case in the residence.

On Tuesday, June 30, 2015, at around 1415 hours, Det. Murray and I made contact with Dr. Anita Wilborn at her office, 1411 N Flagler Dr. Ste 3800. Dr. Wilborn explained that Sheffield became her patient in October 2014 for and Dr. Wilborn subsequently prescribed Sheffield the medications located in her bathroom. Sheffield was last seen by Dr. Wilborn in March 2015 for a lymph node in her neck; however, all tests came back clear and Sheffield was given a clean bill of health otherwise. I asked about the side effects for and Sheffield's medication. Dr. Wilborn advised that there were none for this type of behavior.

Next, at around 1500 hours, Det. Murray and I made contact with Louise Devivo and Jared Smith at Good Samaritan Hospital. Mrs. Devivo is the Director of Cardiology and Mr. Smith is the Chief Operating Officer for the hospital. Mrs. Devivo advised that she became aware of Sheffield's absence from work Saturday when Sheffield's attorney called the hospital. Mrs. Devivo advised that Sheffield's work schedule is from Friday through Monday; off Tuesday through Thursday. Mrs. Devivo is aware that Sheffield has taken days off for court regarding Elizabeth and her custody battle over Xavier. Other than that though, Sheffield had an excellent work history. She had been employed at the hospital since 1991. In regards to Sheffield's last day of work, Mrs. Devivo advised that Sheffield did show up to work on Friday at 0700 as scheduled; however, left early at around 1500 hours because she was not feeling well. Nurse Diana Ball, 12-6-57, spoke to Sheffield before she left work.

Det. Murray and I spoke to Mrs. Ball. Ball advised that she only communicated with Sheffield in a work capacity. On Friday, she ran into Sheffield who "sounded horrible" and "looked severely congested as if she had a head cold". Sheffield told Ball that she did not feel well and asked Ball to cover the reminder of her shift which Ball did.

Det. Murray and I also spoke to co-worker W/M Mario Mosos, 7-9-69. Mr. Mosos explained that he and Sheffield were friendly at work. He stated Sheffield was drawn to him as they shared similar interests such as fishing and shooting. Mosos stated that Sheffield was worried about an "infrastructure meltdown" and

had a passion for guns, prepping and survival. He was aware that Sheffield purchased a small hammerless revolver about a year or so ago. The two wanted to go to the shooting range together but never got to it. Mosos stated that Sheffield did not appear irrational in any way and that the prepping appeared to be a hobby at best. Last, Sheffield did not show any signs of depression or other suspicious characteristics.

After the interviews, Det. Murray and I were provided a box of Sheffield's property and her Human Resources file. Det. Murray looked over the box of property while I looked over Sheffield's file. In her file, I saw that Sheffield was hired in 1991 as a child care custodian and later graduated to EKG Technician where she has been since. Sheffield received consistent yearly satisfactory performance reviews; consistent with Devivo's description of Sheffield. I did not see any negative discipline or any evidence of suspicious activity or concerns in her file. I then called Mr. and Mrs. Hamilton who consented to have Det. Murray and I collect Sheffield's property and bring it to them at the police department.

At around 1800 hours, Mr. and Mrs. Hamilton came to the police department to retrieve Sheffield's property collected from Good Samaritan Hospital. During a recorded interview, the property was itemized to include a red bible. In addition, Mrs. Hamilton identified her mother's handwriting on the journal. Please see a copy of the interview for further.

At around 1900 hours, Derek Neff came to the police station to collect his IPhone. When I had searched his phone, I observed that the last text message he received from Elizabeth's phone number was at 1207 hours on Friday. It stated that she would be in front of Dick's at 6pm. In addition, I observed that Derek saved several text messages between him and Elizabeth regarding Xavier to include topics such as custody issues, money, Xavier's clothing, etc. I did not see anything suspicious that I interpreted to be directly related to this incident.

On Wednesday, July 1, 2015, at around 1845 hours, Det. Murray and I conducted a recorded interview with Erica Reyes, the daughter of Roberto who babysat Sofia this past Wednesday while Elizabeth and Sheffield were in court. Erica stated that when Elizabeth and Sheffield returned home they appeared tired. She did not hear any yelling, screaming or anything else suspicious. That was the last time she saw and spoke to any of them.
