Dear Ms. Montanari,

The City is issuing your permit for a demonstration to be held on Tuesdays in the vicinity of 1800 Thibodo Road. The permit request is approved through September 30, 2017, and is accompanied by the following conditions.

- Participants must follow the law. Participants who do not comply with applicable laws concerning roadway safety and use of the street may be subject to appropriate enforcement action.
- Participants electing to use the public right-of-way outside of the lanes of travel on the west side of the street do so at their own risk since there are no sidewalks on that side and no barriers to automotive intrusions.
- Participants must not impede access for non-participants using the sidewalks, or access to the building or the parking lots. Participants who violate applicable laws by impeding access for non-participants using the sidewalks or access to the building or the parking lots may be subject to appropriate enforcement action.
- Participants who use amplified sound materially above and beyond ordinary ambient noise levels of the rally's location in a manner that disturbs the peace may be subject to appropriate enforcement action under applicable laws.
- If a gathering is expected to have a higher number of participants than the number indicated on the permit application (over 300), the organizers should contact me in advance of the activity.
- The event must adhere to the location, date and time limits on the permit unless amended otherwise.
- If you wish to amend the permit in any form, including any change in location, you should contact me in advance of the changed activity.
- The permit does not authorize participants to trespass on private property.

As the recipient of this permit you are responsible for your own conduct and conduct that you have directed, but not that of others acting outside your direction.
