	<p>On 2/26/2017 I was dispatched to 2000 South Ocean at approximately 0021 to a report of a naked female, later identified as a naked male running around the property. While enroute, dispatch advised that a male was observed through a peep hole breaking down the door at apartment 18F and then physically assaulting another male. Lt. Adams and Officer Fowler made contact with an Asian female, later identified as Saranchimeq Enkhbayar, in the lobby of 2000 S. Ocean who advised that there was a physical altercation in the apartment. LT Adams and Ofc Fowler arrived to the apartment and observed a B/M, later identified as Michael E. Ramsay, sitting in a chair inside of apartment 18F completely naked. The white male, later identified as Dennis Duddy, was the resident of the apartment and identified himself as such when officers arrived. LT Adams and Ofc Fowler gave Ramsay verbal commands to get onto the ground and then placed him into handcuffs. Ramsay was sweating profusely and under the influence of an unknown narcotic.</p> <p>I then spoke to Enkhbayar who advised that her and Duddy were woken up by loud banging coming from their front door. Enkhbayar thought that Duddy opened the door to the apartment at which time a large black naked man, Ramsay, hit Duddy in the head with a vase and then a vase table which was originally in the lobby outside of the apartment. Enkhbayar then observed Duddy and Ramsay in a physical altercation. Enkhbayar was able to get out of the apartment and went to the on-scene security for the property to notify law enforcement.</p> <p>Duddy stated that he walked over to the front door after hearing the banging on the door. Moments later the door gave way and broke open, and a black male, Ramsay, entered his apartment and attacked him by hitting him in the head with a vase and a vase stand. Duddy stated him and Ramsay fell to the ground and began wrestling. Duddy stated that while they were on the ground fighting, Ramsay pulled a large portion of his hair out from the left side of his scalp. Duddy had no knowledge of who Ramsay was and he never</p>

The approximate damage to front doors, doorframe, walls, vase and vase stand is \$3500.00</p> <p>While on scene I observed heavy damage to the left front door which had obvious signs of being forced inward to enter the residence. The frame at the top of the door was damaged, the dead bolt was still in the locked position, the door was forced so hard that the door knob went into the drywall, and other portions of the door were splintered. The approximate damage to front doors, doorframe, walls, vase and vase stand is \$3500.00 Upon entering the residence there was a broken vase and a bent vase stand and a large clump of Duddy's hair. Duddy's shirt was ripped and he had a scratch mark on the left side of his face. There was a hole to the lower dry wall on the east side of the entrance to the apartment. CST McDonald processed the scene.</p> <p>Ramsay was transported to Boca Raton Regional Hospital due to him stating he took two hits of acid and he was sweating profusely. Ramsay had no knowledge at this time of what occurred and was unable to provide any statement. Duddy was also transported to Boca Raton Regional Hospital for evaluation due to head pain.</p> <p>Detective Lamia and Detective Rucco arrived on scene to assist in the investigation.</p> <p>At this time Michael Ramsay is being charged with Burglary with a Battery, FSS 810.02(2a), Burglary with a dangerous weapon, FSS 810.02(2b) and Burglary causing damage to property in excess of \$1000.00 dollars 810.02(2c2). Aggravated battery using deadly weapon, FSS 784.045(1a2). Ramsay was medically cleared and transported to Boca Raton PD booking for further processing then taken to Palm Beach county Jail.</p>
