Growing up, Larry was always there with a helping hand. I remember him being late for dinner numerous times due to his involvement as a Sports Trainer in his Junior and Senior year of High School. He always researched techniques, even then, to help the athletes. As the years progressed, he studied and became more knowledgeable of sports related injuries.

In addition to working with sports related injuries, Larry was very active in his church and community. Larry taught Sunday School, and worked with young married couples with his wife in the church setting. Within his community, Larry volunteered to be team doctor for the high school football team. He also was running for school board for his community, receiving 21% of votes even when he had his name withdrawn.

Larry has three children. His oldest daughter, has severe Autism. Larry took an active role in her educational well being. Larry also established a fund raising program, Gymnastics Doctor Autism Foundation, for students with Autism. He later expanded this program to meet all the special needs population.

When my husband had a stroke several years ago, Larry was called and immediately left his home to be with me in the hospital. He was there to comfort me and give medical advice. Larry knew which hospital was best to meet my husbands rehabilitation needs and he had him transferred there.

Larry was the ultimate volunteer. He never charged for any of his services. Many of his athletes did not have financial resources or insurance to pay for his medical expertise.

I would also like the court to know that I do love my brother very much and will continue to support him. I continue to pray for him and everyone involved. Thank you for the Court's time.

I am writing this to tell you some personal information about Larry and his family from an outside the family perspective.


Larry Nassar was raised by a very loving Christian family. He was the fifth of 5 siblings. His parents had extremely strong moral values and they always wanted what was best for all their children. In addition, higher education was a top priority. My wife North was the oldest, and she earned and completed her Masters Degree plus 30 hours in Special Education and Guidance Counseling. Sister Land graduated from University of Detroit with a degree in Dental Hygiene. She furthered her education and became an Assistant Professor at Oakland Community College and taught Dental Hygiene. Brother Paragothis degree in business and was a Finance Controller for a large paper company in Detroit. Brother Manager graduated from the University of Michigan with a Dental degree. And of course Larry, a graduate of U of M with a degree in Kinesiology and later graduating from Michigan State as a DO Doctor with emphasis in Sports Medicine.



Larry was able to help this cellmate by doing what he does best and the pain was gone. He became known as the "Miracle Doctor" with the Spanish inmates. He also helped another inmate reach out to his son in a positive manner. Last Christmas, Larry asked family members to send books written in Spanish for his roommates so that they could have a bit joy during that time of year. Larry has been involved in prison Bible Study and has completed all the lessons.

Dear Judge Neff,

My name is Lam Larry Nassar's sister. As he is 12 years my junior, I have known him his entire life.

I am writing to tell you some positive things about Larry as a person that I hope the Court will consider when passing sentence.

As the youngest in the family, Larry was the best buddy to his older brother of two years,

Manne was the one who originally got Larry involved in sports. Manne was the first athletic
trainer for his high school. He tagged Larry to take his place when he graduated and Larry learned the
job quickly. Larry took his position as trainer very seriously. Gentle of heart, Larry always looked for
ways to make things better for those around him.

As a dancer, myself, I tagged both boys to be extras in my troupes holiday performances of "The Nutcracker". Larry went to dance practice and rehearsals with me as well as watching as I taught classical ballet. It didn't take him too long to figure out the football players would benefit from some of the stretching exercises the dancers did. He went to the football coach and was approved to start some of the stretches with the players reducing the number of ankle, knee and hamstring injuries. He also worked on designing a quick release helmet to minimize head and neck movement for football players that went down with suspected head / neck / or back injuries during a game. Early on in his career in the training room, Larry designed huge reference posters that were posted in the training room and locker rooms for the coaches and players to know when to ice and when to apply heat to an injury.

Once he started working with the gymnastics teams, he developed several things to help them. He developed a chalking 'cooltron' device. The device keeps the chalk the athlete uses on their hands before swinging on the parallel bars. He developed this to reduce hand blisters. Noticing how many gymnasts had issues with their wrists and ankles, led Larry to develop the Nassar System...a supporting strap system that athletes around the world have used. In production of the strap system, he enlisted the help of his engineer father and home maker mother. Dad made the straps to Larry's specifications and mom filled the orders and mailed them.

It is Larry's love of sports and keeping athletes in peak performance that drove him to become a sports medicine doctor. He has devoted hours to developing nutrition guides and exercise regimens to promote good health and physical strength in athletes to prevent injury and keep them in peak performance.

As a neighbor, Larry takes care of those around him. When it snowed, he would be out, no matter the time, to snow blow or shovel several of his neighbors walks and driveways. He use to joke that it was his way of getting exercise, especially before he got a snow blower. He has been known to run across the street barefoot in the winter to come to the aid of a neighbor who was experiencing symptoms of a heart attack or down a few houses to see what he could do to help a wheel chair bound young neighbor. He put up the latest in backyard play capes for his children and neighborhood kids to come to play on so they could play safe under the watchful eye of his wife or himself. He would be out in the yard doing yard work, gardening, or working in their vegetable garden while the kids would play.

Larry's oldest daughter is autistic. But instead of looking at this as a tragedy that had fallen upon his family, he looked at her autism not as a problem to be solved but as a potential to be realized and developed the Gymnastics Doctor Autism Foundation to raise the awareness of autism and what those with autism and other special needs can achieve through sports involvement. He has spent hours researching and publishing material to support the advantages for the special needs athlete and the coaches and teams they become involved with, explaining how involvement with a special needs individuals is beneficial and rewarding for the individuals and those who work with them.

Since his daughter had a hard time sitting in a church service, Larry found away to still get to church with his family and keep her involved in her faith. He became a Sunday school teacher so he could keep his daughter safe during a church service since she couldn't sit through a whole one. He would take her to class with him where he could keep an eye on her in the classroom while he taught the children about their faith.

Larry takes his role as a Godparents very seriously. His is Godfather to his wife S college roommate's three children. When this roommate divorced, Larry and S were instrumental in moving her and the children to Michigan and getting them established in a place not too far from their home. They helped her find work and have taken in the children, growing their family to having 6 children. They took over the supervision of: sending the children off to school in the morning, chauffeuring them to and from after school activities that Larry and S the children involved in and paid for, homework, discipline and all the other things that go with raising young kids.

As his children become involved in the public school system, Larry and his wife became very vocal when changes were being made that were not in the best interest of all the children in the district. With the closing of an elementary school, all the students were to be put into a lottery for placement in the remaining schools. It soon became apparent that the students in the school that was to be closed were the last to be placed. Thus the lottery system the parents were told was in place was not a true lottery for all the children were not treated equally. Attendance at school board meetings became a part of Larry and his wife's responsibilities. They felt so strongly about the changes that needed to be made to the school district that Larry ran for school board.

Larry was also instrumental in getting the state law changed, by sitting on the "Let 'em play" committee to make it possible for special needs individuals over the age of 18 to participate in their high school sports programs. To help ensure that athletes are properly cared for, Larry sat on the Athletic Trainer State Board approved by the former state governor Granholm and current governor Snyder and wrote the rules/laws that govern Athletic trainers in our state.

In closing, I would like the court to know that I love my brother with my very being and I will always support him. I pray daily for him, his lawyers, his judges and for the others involved in his case. I thank the court for taking the time to consider what I have written.
