

MARJORY STONEMAN DOUGLAS HIGH SCHOOL SHOOTING

TIME LINE OF EVENTS

<u>Policy and Training</u>: The Broward Sheriff's Office active shooter policy is based upon current law enforcement best practices and calls for personnel to interrupt and engage suspects who are actively engaged in the shooting of others. This procedure was reinforced through an extensive active shooter and rescue task force training program delivered to BSO Department of Law Enforcement sworn personnel between 2014 and 2016. Instruction included scenario based training for single and multiple officer responses. This training stresses the engagement of a suspect who is actively shooting to 1) eliminate the threat, 2) cause the suspect to barricade or 3) cause the suspect to surrender. If the sounds of shooting cease, deputies are to group and search for victims with the formation of a rescue task force being the ultimate goal.

Estimates of Time: The investigation is active and continuing. The chronology is based upon the information received and analyzed at the time of this report and may change. Times are based upon estimates and time stamps provided by its source system (different clocks). Video entries correspond to the initiation of the described activities. Communications times may also reflect the time of CAD entry and not necessarily the actual time of transmission. As a result, time line entries may have occurred out of the listed chronologic order and/or may overlap with other entries.

<u>911 System</u> — While the Broward Sheriff's Office operates the Regional 911 system that is maintained by Broward County, the City of Coral Springs is not part of this system and operates its own separate center. The City of Parkland contracts BSO for its law enforcement services and the Coral Springs Fire Department for its fire rescue and emergency medical services. Under this arrangement, **ALL Parkland cellular 911 calls** are routed to the Coral Springs Communications Center. Coral Springs is then tasked with routing these calls to either CSFD for fire rescue and/or BSO for law enforcement calls.

911 Call Records provided by BSO Regional Communications showed the following:

- BSO received an estimated 71 incoming calls into their communications center during the incident (14:22 to 15:35 hrs).
- No abandoned calls have been identified at this time.
- Only one inbound call has been identified as originating from the school. (14:27:04 hrs) A male was heard whispering that someone was shooting at the school and the line disconnected.

911 Call Records provided by Coral Springs Communications showed the following:

- Coral Springs received an estimated 86 incoming calls into their communications center during the incident (14:22 to 15:35 hrs).
- Callers abandoned 21 of these calls (i.e hung-up, disconnected, dropped prior to being answered).
- Three (3) calls were transferred to BSO for the police response.
 - 1. (14:22:44 to 14:25:41 hrs) Coral Springs Operator 546 contacted BSO Communications with second hand information.

(BSO time stamp – 14:23:37) Coral Springs advised a caller (student) informed them there is a shooting at Stoneman Douglas High School. Call updated and CS Operator advised shots were heard in the background. Update: No initial location could be provided. Attempt by CS operator to re-contact caller was unsuccessful.

(BSO time stamp: 14:24:32) Update: separate call received of someone shot in 1200 building.

(BSO time stamp: 14:25:00) Update: multiple calls with shooting in background.

(BSO time stamp: 14:25:18) Update: one confirmed patient in the 1200 building (Call ended 14:25:41)

- 2. (14:27:38 to 14:28:53 hrs) Coral Springs Operator with a transfer. Caller disconnected before transfer advised that the shooter is in the student parking lot on the north side of the school. No description.
- 3. (15:00:00 to 15:03:18 hrs) Coral Springs transfer. Third hand information that suspect "is wearing a vest."
- BSO did not receive updates concerning the suspect (i.e. number(s), location, description, activities).

<u>Radio Communications</u>: BSO uses the Broward County radio system and has the ability to monitor and merge channels on those systems during joint operations. The Coral Springs Communications System operates separately and attempts to patch these systems prior to the entry of Building 12 were unsuccessful. Therefore, **BSO and CSPD personnel were not able to communicate via a common channel during the outlined time line provided below**.

Radio System Failures: The current radio infrastructure is maintained by Broward County and nearing its end of life. Broward County has indicated it is scheduled to replace the current system in CY 2019. The capacity of radio communications can become impaired when an excessive number of users access the system. This impairment, otherwise known as "throttling," occurred at some point during the incident and hindered radio communications; whereas users may have been unable to transmit or receive some radio messages. This issue is being further analyzed.

<u>School Security Video</u>: The 45 acre campus is equipped to record 70 different camera angles. Most of these views provide coverage of student buildings, walkways and hallways. Building 12 was covered by thirteen interior cameras. School video time stamps are not exactly synchronized with BSO dispatch records. Cameras are also motion activated leaving gaps in coverage.

<u>School Radio</u>: Throughout the incident SRD Peterson communicated with school security personnel over their hand held radio system. Transmissions are not recorded.
