## PETITIONERS' VERIFIED COMPLAINT FOR DECLARATORY JUDGMENT

Come now Petitioners, Cathy Moses and Paul F. Weinbaum, and for their Verified Complaint for Declaratory Judgment against Defendant, Hanna Skandera, Secretary of Education, New Mexico Public Education Department, state:

- 1. As reflected in the attached Verifications, each of the Petitioners is and has been continually a resident of the State of New Mexico for a period of five or more years and during such period has continually been a taxpayer in the State of New Mexico (the "State") by the payment of income taxes on earnings, sales taxes on purchases and/or real estate taxes on their residences. In addition, each Petitioner currently has one or more children attending the elementary and/or secondary public schools of the State.
- 2. Defendant, Hanna Skandera, is the duly appointed Secretary of Education of the State's Public Education Department.
- 3. The continued funding and distribution of textbooks and other instructional materials to private schools, at public expense, as provided in the NMSA §§

22-15-1 to 14 (the "Act") is unconstitutional, being violative of Article IX, § 14, Article XII, § 3, Article IV, § 31 and/or Article II, § 11 of the New Mexico Constitution.

WHEREFORE, Plaintiffs pray a finding and order of this Court declaring NMSA §§ 22-15-1 to 14, whereby public funds are authorized and instructed to be used for the distribution of textbooks and other instructional materials to private schools, to be violative of Article IX, § 14, Article XII, § 3, Article IV, § 31 and/or Article II, § 11 of the New Mexico Constitution, granting such other and further relief as this Court deems appropriate under the circumstances and taxing all costs herein against Defendant.
