Trump, pursuant to CPLR § 5601(b)(1), appeals to the Court of Appeals from the order of the Appellate Division, First Department, entered in the office of the Clerk of the Appellate Division on May 17, 2018, denying his motion for a stay pending his appeal to the Appellate Division from the March 20, 2018 order of the Supreme Court denying his motion to dismiss on the threshold ground, among others, that a sitting United States President is immune under the Supremacy Clause of the United States Constitution, Article VI, Section II, from suit in state court during his or her term in office, which Appellate Division order is a final appealable order because (a) absent this appeal, both that order and the Supreme Court’s order would be effectively unreviewable, and (b) the appeal involves the construction of the Supremacy Clause.
