FELONY COMPLAINT FOR ARREST WARRANT

The undersigned is informed and believes that:

COUNT 1

On or about February 24, 2016, in the County of Los Angeles, the crime of VOLUNTARY MANSLAUGHTER, in violation of PENAL CODE SECTION 192(a), a Felony, was committed by LUKE LIU, who did unlawfully, and without malice kill FRANCISCO GARCIA, a human being, by intentionally and knowingly committing an act dangerous to human life and deliberately acting with conscious disregard for human life.

"NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c) and a serious felony within the meaning of Penal Code section 1192.7(c)(1)."

It is further alleged that in the commission and attempted commission of the above offense, the said defendant(s), LUKE LIU, personally used a firearm(s), to wit: handgun, within the meaning of Penal Code section 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

It is further alleged that the defendant(s), LUKE LIU is ineligible for probation pursuant to Penal Code Section 1203(e)(2).

It is further alleged that the defendant(s), LUKE LIU is ineligible for probation pursuant to Penal Code section 1203(e)(3).

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and Cunningham v. California (2007) 549 U.S. 270.

NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.

NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.

NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form ("PPR") pursuant to Penal Code § 29810.

Further, attached hereto and incorporated herein are official reports and documents of a law enforcement agency which the undersigned believes establish probable cause for the arrest of defendant(s) LUKE LIU for the above-listed crimes. Wherefore, a warrant of arrest is requested for LUKE LIU.
