IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, DANIEL ABRAHAM TREVINO, hereafter styled the Defendant, heretofore on or about December 2, 2018, did then and there unlawfully, with knowledge of the issuance of a magistrate's order for emergency protection issued under Article 17.292 of the Code of Criminal Procedure, a copy of which is attached as Exhibit A did violate said order by intentionally and knowingly committing the offense of assault of Christina Trevino, namely, by intentionally causing bodily injury to Christina Trevino by striking her with his head.

Before the commission of the offense alleged above, on October 20, 2015, in Cause No. 1470100, in the 351st District Court of Harris County, Texas, the Defendant was convicted of the felony offense of Felon in Possession of a Weapon.

PC Statement:

Affiant, Mateo Ordonez, a Deputy with the Harris County Precinct Four Constable's Office, believes and has reason to believe that Daniel Abraham Trevino, hereafter the Defendant, did commit the offense of Violation of a Protective Order on or about December 2, 2018 in Harris County, Texas. Affiant's belief is based on the following facts:

On December 2, 2018, Affiant was dispatched to 3020 Gears Road, Harris County, Texas, regarding an assault call. Affiant spoke with the Christina Trevino, hereafter the Complainant, who reported that on this date, the Defendant, Daniel Abraham Trevino, who she knows by name and sight because he is her boyfriend, accused her of having a previous sexual encounter with an old friend she met at a bar located at 12033 Veterans Memorial Drive, Harris County, Texas. This initiated an argument. Complainant reported that while still at that location, the Defendant head-butted her with his forehead, striking Complainant on her left cheekbone below her left eye. Complainant reported there is currently an Aggravated Assault - Family Violence charge pending against the Defendant in which she is the listed Complainant. The Complainant advised she currently has a Magistrate's Order of Emergency Protection against the Defendant, which was put in place October 26, 2018. Affiant confirmed this. Complainant agreed to provide voluntary statements of the incident, however, she did not want to pursue charges for this Violation of a Protective Order because she is in fear for her life and believes the Defendant will retaliate against her.
