
1 The motion of Plaintiff and Petitioner People of the State of California ex rel. Attorney  
2 General Becerra (the People) against defendant and respondent Westlands Water District  
3 (Westlands) came on for hearing on July 15, 2019, in Department 8 of this Court, Honorable  
4 Tamara L. Wood, presiding. After considering all of the moving, opposition, and reply papers  
5 and argument provided by counsel at the hearing, the Court GRANTS the motion for preliminary  
6 injunction and ORDERS as follows:

7 1. Westlands is enjoined from ~~assisting or cooperating in any~~ *taking any action that constitutes*  
8 construction of the Shasta Dam Raise project, pending trial of this matter.

9 2. The CEQA process initiated by Westlands' issuance of an Initial Study/Notice of  
10 Preparation in November 2018 is enjoined, pending trial of this matter.

11 ~~3. Westlands is enjoined from taking any action that would violate the California Wild  
12 and Scenic Rivers Act, Public Resources Code section 5093.542, pending trial of this matter.~~ *AD*


