
Assistant Attorney General Boyd,

I write today to ask for a review of the enclosed constituent letters regarding alleged practices taken by Pembina toward affected landowners in the proposed Jordan Cove Liquid Natural Gas (LNG) project in Oregon.

The enclosed letters lay out many alleged concerns with the proposed LNG pipeline running through Coos, Douglas, Jackson, and Klamath counties. These letters contain concerns alleging Pembina is using possibly abusive business practices towards landowners opposed to the Jordan Cove LNG project. These landowners include seniors and widows, and grievances include alleged trespassing, harassment, and intimidation.

This proposed project aims to go through mostly rural areas in my state, and affects many elderly landowners. The idea that seniors, or anyone for that matter, are being improperly pressured into signing agreements is simply unacceptable. I ask that you investigate these concerns and respond to the constituent as well as to my office.
