

IN THE NAME AND AUTHORITY OF THE STATE OF TEXAS BEFORE ME, the undersigned authority, on this day personally appeared Det. Adrian Garcia #2191, who after being by me duly sworn, on oath deposes and says that he has good reason to believe and does believe that heretofore to wit: on or about the 3rd day of August 2019 and before the filing of this complaint in the County of El Paso, the State of Texas, one Patrick Wood Crusius 07-27-1998, Hereinafter called the DEFENDANT, did then and there unlawfully, commit the offense of Capital Murder defined in Section 19.03, by Intentionally and Knowingly commits Murder and the person murders more than one person during the same criminal transaction.

The incident occurred in the City and County of EL Paso, TX.

The affiant is in possession of an official police report, which includes, witness statements, case photos and evidence information supporting the following facts.

On August 3, 2019, at approximately 1039 hrs, El Paso Police Officers responded to 7101 Gateway West (Wal Mart) in reference to a "disturbance Call" which later upgraded to an "Active Shooter" in progress. When officers arrived to the scene they observed multiple victims deceased showing no signs of life.

Texas DPS Ranger's were responding to the scene traveling Westbound at the 7700 Block of Viscount operating un-marked vehicles with emergency lights and sirens activated. Agents observed a vehicle in front of them at the intersection of Viscount and Sunmount stopped at the left turn lane. Agents and police officers at the intersection then observed a male person (defendant) to exit out of the vehicle with his hands raised in the air and stated out loud to the agents "I'm the shooter".

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

The defendant was placed under arrest and transported to police headquarters. The affiant and Det. A. Hernandez #1570, met with the defendant inside interview room #4. The affiant provided the defendant his Miranda Rights which he waived and agreed to speak about the incident. The defendant stated he drove to the listed location from Allen, TX and entered the store with an assault rifle (AK-47) and multiple magazines. The defendant stated once inside the store he opened fire using his AK-47 shooting multiple innocent victims. The defendant stated his target were "Mexicans".

Multiple victims were transported to area hospitals where one was pronounced deceased at an area hospital and 19 were confirmed deceased at the listed address.
