AFFIDAVIT OF VAN M. KASMIROSKI IN SUPPORT OF PLAINTIFF CONOCOPHILLIPS COMPANY'S MOTION FOR TEMPORARY INJUNCTIVE RELIEF

I, Van M. Kasmiroski, state:

- 1. I am over 18 years of age and competent to testify to the matters stated herein.
- 2. I am employed by ConocoPhillips Company as the Lower 48 Security Program Manager.
- 3. I have twenty-two years of law enforcement experience at the city, state, and federal levels.
- 4. From 2003 to 2013, I was a Special Agent for the United States Secret Service where I performed several roles. From 2003 to 2010, I was assigned to the Office of Investigations

conducting criminal investigations into activities related to fraud, money laundering, and counterfeiting. From 2010 to 2011, I was assigned to the Office of Protective Operations for the Secretary of Treasury, and from 2011 to 2013, I was assigned to the Office of Protective Operations for the Vice President.

- 5. From 2016-2018, I was Special Agent in the Criminal Investigations Division for the Treasury Inspector General for Tax Administration.
- 6. Prior to my work for the federal government, I was a police officer for the City of Plano, Texas and an Enforcement Agent for the Texas Alcoholic Beverage Commission.
- 7. I completed an investigation on behalf of ConocoPhillips Company into the matter involving the actions of Troy Holland and HIC Energy Partners, LLC during July 2019.
- 8. As part of my investigation, I interviewed witnesses, including Caroline Hinze, and reviewed company documents and emails related to the allegations contained in this Complaint.
- 9. I also performed online, open-source Google searches of both HIC Partners and Troy Holland.
- 10. As a result of those searches, I determined that the Twitter account for HIC Partners appears to have been taken down.
- 11. In addition, I located images online purporting to be of Troy Holland of HIC Partners. Those images contained links to the HIC Partners web page. When I clicked on those links, I was directed to the HIC Partners' website which states that the information has been removed from the account.
- 12. A review of the addresses in ConocoPhillips contracts revealed locations that do not appear to be affiliated with HIC Partners or Holland.

- 13. Multiple attempts have been made to reach Holland and an employee of HIC Partners, Blaine Wicklein, by telephone and a demand letter. Holland has not returned any calls or responded to the demand letter.
- 14. On or about August 9, 2019, I reported the incident on behalf of ConocoPhillips to a special agent with the Federal Bureau of Investigation ("FBI").
- 15. The FBI turned the case over to the Department of Justice, which I understand has begun an investigation into the matter.
