**IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:**

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **TIFFANY MONIQUE HENDERSON**, hereafter styled the Defendant, heretofore on or about **December 11, 2019**, did then and there unlawfully, with intent to hinder the arrest to Tavoress Henderson for a felony offense harbor and conceal and provide and aid in providing a means of avoiding arrest and effecting escape to Tavoress Henderson and Tavoress Henderson who was as known to the Defendant charged with and under arrest for a felony offense.

Before the commission of the offense alleged above, on August 29, 2005, in Cause No. 1037629, in the 351st District Court of Harris County, Texas, the Defendant was convicted of the felony offense of Assault- Public Servant.

**PROBABLE CAUSE:**

AFFIANT, RYAN HILZ, A CERTIFIED PEACE OFFICER PRESENTLY EMPLOYED AS A DEPUTY INVESTIGATOR WITH THE HARRIS COUNTY SHERIFF'S OFFICE HAS GOOD REASON TO BELIEVE AND DOES BELIEVE THAT ON 12/11/2019 TIFFANY MONIQUE HENDERSON and GEOFFREY MICHAEL WHEELER DID COMMIT THE FELONY OFFENSE OF HINDERING APPREHENSION IN HARRIS COUNTY, TEXAS.

MY BELIEF IS BASED ON THE FOLLOWING:

ON TUESDAY, DECEMBER 10, 2019, UNITS FROM THE HARRIS COUNTY SHERIFF'S OFFICE HOMICIDE AND VIOLENT CRIME INVESTIGATORS, INCLUDING AFFIANT, RESPONDED TO 2002 SAN SABASTIAN COURT HOUSTON, HARRIS COUNTY, TEXAS IN REFERENCE TO THE MURDER OF SGT. K. SULLIVAN WHO WAS RUN OVER BY TAVORES HENDERSON, WHO FLED A TRAFFIC STOP ON 12/10/2019. THROUGH FURTHER INVESTIGATION BY INVESTIGATORS, AN ADDRESS FOR TAVORES HENDERSON'S MOTHER, IDENTIFIED AS TIFFANY HENDERSON DOB 06/19/1982 BY HER TEXAS GOVERNMENT ISSUED IDENTIFICATION 16255163 HEREAFTER DEFENDANT#1, WAS LOCATED AT 4206 SHELBY CIRCLE HOUSTON, TX. AFFIANT LEARNED FROM INVESTIGATOR E. BARNOT AND INVESTIGATOR D.LEWIS WITH THE SHERIFF'S OFFICE, WHO AFFIANT KNOWS TO BE RELIABLE AND CREDIBLE, RESPONDED TO 4206 SHELBY CIRCLE AT APPROXIMATELY 12:55 AM DECEMBER 11, 2019. AT APPROXIMATELY 1:10 AM ON DECEMBER 11, 2019, DEFENDANT#1 ARRIVED AT HER ADDRESS ALONG WITH HER BOYFRIEND, IDENTIFIED AS GEOFFREY WHEELER DOB 05/19/1986, BY HIS TEXAS DRIVERS LICENSE 21108846 REFERRED TO HEREAFTER AS DEFENDANT#2, IN A RED TOYOTA HATCH BACK. INVESTIGATORS BARNOT AND LEWIS SPOKE WITH DEFENDANT#1 ABOUT HER WHEREABOUTS AND SHE STATED THAT SHE GOT OFF WORK AT 11:00PM THAT NIGHT, THEN WENT TO PICK UP DEFENDANT#2 AND THEN CAME TO HER RESIDENCE. WHILE SPEAKING WITH DEFENDANT #1 IN THE PRESENCE OF DEFENDANT#2, DEFENDANT#1 WAS SHOWN A KNOWN PHOTOGRAPH OF TAVORES HENDERSON AND TOLD THAT OFFICERS WERE THERE TO ARREST HIM FOR THE MURDER OF A POLICE OFFICER. INITALLY DEFENDANT#1 DENIED KNOWING WHO TAVORES HENDERSON WAS. AFTER FURTHER CONVERSATION, DEFENDANT#1 ADMITTED THAT SHE WAS THE BIOLOGICAL MOTHER OF TAVORES HENDERSON. INVESTIGATORS CONTINUED TO SPEAK WITH DEFENDANT#1 AND DEFENDANT#2 ABOUT WHERE TAVORES HENDERSON WAS LOCATED AND THEY BOTH DENIED HAVING ANY KNOWLEDGE OF WHERE TAVORES HENDERSON WAS LOCATED. SHE DID TELL OFFICERS THAT THERE WAS A LOCKED ROOM INSIDE HER HOUSE THAT TAVORES HAD A KEY TO SO OFFICERS DECIDED TO WAIT FOR A WARRANT BEFORE THEY ENTERED THE RESIDENCE. LATER IN THE MORNING OF DECEMBER 11, 2019 ONCE IT WAS DAYLIGHT HCSO WHILE AT DEFENDANT #1'S RESIDENCE WITH DEFENDANT#1 AND DEFENDANT#2 BEING PRESENT AT 4206 SHELBY CIRCLE HOUSTON, HARRIS COUNTY, TEXAS OFFICERS WAITED AND RECEIVED NOTICE THAT THE ARREST WARRANT FOR TAVORES HENDERSON CHARGING HIM WITH FELONY MURDER HAD BEEN SIGNED ENTERED THE RESIDENCE LOOKING FOR

BUT DO NOT FIND TAVORES HENDERSON. WHILE OFFICERS ARE THERE WITH DEFENDANT#1 AND DEFENDANT #2 A NEWS BROADCAST WAS MADE OVER TV MEDIA STATING THAT TAVORES HENDERSON HAD BEEN CHARGED WITH FELONY MURDER OF THE POLICE OFFICER. DEFENDANT#1 BEGAN CRYING AND WAILING WHEN SHE HEARD THIS ANNOUNCEMENT. BEFORE THEY LEFT THE LOCATION OFFICERS INFORMED BOTH DEFENDANT#1 AND DEFENDANT#2 AGAIN TO INFORM HCSO OFFICERS IF THEY OBTAINED ANY KNOWLEDGE OF TAVORES HENDERSON'S WHEREABOUTS. NEITHER DEFENDANT#1 OR DEFENDANT#2 OFFERED ANY FURTHER INFORMATION OR KNOWLEDGE OF TAVORES HENDERSON'S WHEREABOUTS.

THROUGH FURTHER INVESTIGATION AND TIPS, AFFIANT AND HCSO OFFICERS LEARNED THAT TAVORES HENDERSON HAD BEEN TAKEN TO A HOTEL, THE STERLING INN, LOCATED AT 2500 SOUTH LOOP WEST HOUSTON, HARRIS COUNTY, TEXAS THE NIGHT OF THE INCIDENT, DECEMBER 10, 2019 OR EARLY MORNING HOURS OF DECEMBER 11, 2019, AFTER THE MURDER OF THE POLICE OFFICER, BY DEFENDANT#1 AND DEFENDANT#2. SURVEILLANCE VIDEO WAS OBTAINED FROM STERLING INN HOTEL FOR THE EARLY MORNING OF DECEMBER 11, 2019. INVESTIGATOR R. HILZ WITH THE HARRIS COUNTY SHERIFF'S OFFICE OBSERVED SCREENSHOTS OF THAT SURVEILLANCE FOOTAGE THAT CLEARLY SHOWS TAVORES HENDERSON BEING DROPPED OFF AT THE STERLING INN HOTEL 2500 SOUTH LOOP WEST HOUSTON, HARRIS COUNTY, TEXAS AT APPROXIMATELY 12:30AM ON DECEMBER 11, 2019. THE VIDEO FURTHER SHOWED TAVORES HENDERSON BEING DROPPED OFF BY BOTH DEFENDANT#1, AND DEFENDANT#2 IN THE SAME RED TOYOTA HATCHBACK THEY ARRIVED AT HER RESIDENCE IN LATER ON DECEMBER 11, 2019 WHEN OFFICERS SPOKE WITH HER. IN THE SURVEILLANCE FOOTAGE, DEFENDANT#1 IS DRIVING THE RED TOYOTA HATCHBACK, DEFENDANT#2 IS IN THE FRONT PASSENGER SEAT AND TAVORES HENDERSON IS IN THE BACK SEAT. TAVORES HENDERSON WAS FORMALLY CHARGED WITH FELONY MURDER OF A POLICE OFFICER AT 5:44 A.M. ON DECEMBER 11, 2019, AND THAT FACT WAS BROADCAST ALL OVER HARRIS COUNTY, TEXAS MEDIA THE MORNING OF DECEMBER 11, 2019. NEITHER DEFENDANT#1 NOR DEFENDANT#2 NOTIFIED HCSO OFFICERS OR ANY OTHER LAW ENFORCEMENT OFFICERS OF TAVORES HENDERSON'S WHEREABOUTS AT ANY TIME BEFORE OFFICERS SURROUNDED THE HOUSE HE WAS HIDING IN ON DECEMBER 12, 2019. FROM OTHER SOURCES ON DECEMBER 12, 2019, HCSO OFFICERS RECEIVED INFORMATION THAT TAVORES HENDERSON WAS AT 4235 HERITAGE TRAIL DRIVE IN HOUSTON, HARRIS COUNTY, TEXAS. OFFICERS PROCEEDED TO THAT SCENE AND SURROUNDED THE RESIDENCE AT 4235 HERITAGE TRAIL DRIVE HOUSTON, HARRIS COUNTY, TEXAS. WHILE OFFICERS WERE THERE AND BEFORE ANY SEIGE OF THE RESIDENCE, DEFENDANT #1 ARRIVED WITH DEFENDANT #2, AND THEY WERE NOT CONTACTED PRIOR BY LAW ENFORCEMENT. THEY INFORMED OFFICERS ON SCENE THAT TAVORES HENDERSON WAS IN FACT INSIDE THE RESIDENCE AT 4235 HERITAGE TRAIL DRIVE, HOUSTON, HARRIS COUNTY, TEXAS. DEFENDANT#1 INFORMED OFFICERS THAT SHE WANTED THE OPPORTUNITY TO TELL HER SON, TAVORES HENDERSON TO SURRENDER. DEFENDANT #1 WAS ALLOWED TO SPEAK TO TAVORES HENDERSON AND HE RESPONDED BY SURRENDERING HIMSELF WITHOUT INCIDENT.


I WAS FURTHER INFORMED BY HCSO DEPUTY CRAIG AND DEPUTY THOMPSON THAT THEY INTERVIEWED DEFENDANT#1 AT THE ARREST SCENE, 4235 HERITAGE TRAIL DRIVE AND SHE WAS ASKED WHY SHE LIED ON DECEMBER 11, 2019, AND ALLOWED OFFICERS TO CONTINUE RELYING UPON THAT LIE ABOUT NOT KNOWING THE WHEREABOUTS OF TAVORES HENDERSON UNTIL THEY SURROUNDED 4235 HERITAGE TRAIL DRIVE AND SHE STATED, "BECAUSE I AM A MOM". DEFENDANT #2 WAS ALSO QUESTIONED AS TO WHY HE LIED ABOUT NOT KNOWING THE WHEREABOUTS OF TAVORES HENDERSON AND WHY HE CONTINUED TO ALLOW OFFICERS TO RELY UPON THAT LIE, AND HE STATED, "BECAUSE I WAS SCARED"

AGAINST THE PEACE AND DIGNITY OF THE STATE.
