For good cause shown the Court hereby orders the Davidson County Election Commission and Tre Hargett, Secretary of State, to keep open all polling locations in Davidson County until ~~10:00~~ ^{8:00} pm. The Court finds that voters have been impacted by the inclement and severe weather, that certain polling locations could not open on time, and that voters have been turned away and could not vote as a result of the weather and failure to open polling locations on time. This will result in irreparable harm to the Plaintiffs if prospective voters in their primary are not given sufficient time and opportunity to cast a ballot in the election being held on March 3, 2020. The Davidson County Election Commission is ordered to post ^{the foregoing} on its website that polls ~~will remain open until 10:00pm~~ and alert the media that polls will remain open until that time.


