Saul:

I have listed the budget impacts to case processing at our court below.

- Due to ongoing budget reductions, the Ventura Superior Court is experiencing delays in the processing of new filings judgments, writs abstracts, renewal of judgments and assignment of judgments that has grown from two weeks to six weeks. The largest increase in backlogs are impacting new filings and judgments that now have to be dropped-off and then processed by back-office staff.
- Family Law new petitions and judgments are also required to be dropped-off for processing by back-office staff instead of public counter staff that has resulted in a two to five day delay in processing these documents.

Hope this helps.
