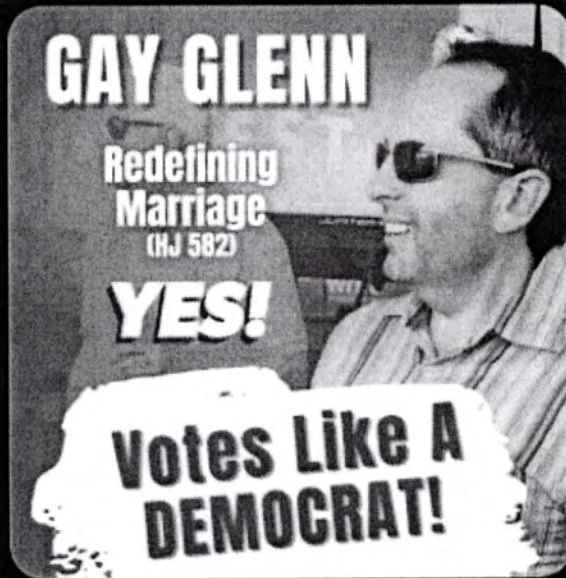

**STATEMENT OF TIM ANDERSON, COUNSEL FOR THE PLAINTIFF**

**PURSUANT TO 8.01-407.1 CODE OF VIRGINIA**

1. My name is Tim Anderson, and I am counsel of record for the Plaintiff in this matter.
2. The attached text message was sent from the 804-294-4477, a telephone number registered in Virginia in the last week of April 2021 to individuals in the Commonwealth of Virginia.
3. The text message contains defamatory and tortious claims against the Plaintiff and are the subject of a lawsuit filed in the Norfolk Circuit Court.
4. The sender of the text message is unknown, but the Plaintiff knows the Onvoy LLC is the owner of the telephone number.
5. Onvoy LLC is a internet service provider providing Voice of Internet telecommunication services in Virginia.
6. The text message was sent by the unknown Defendant via a computer network system over the Internet using the infrastructure owned by Onvoy LLC.
7. There is no way to reasonably discover the identity of the author of the text message without Onvoy LLC disclosing who the registered customer is for the telephone number 804-294-4477.
8. There is no motion to dismiss or motion or other motions filed in the underlying case at this time.
9. Onvoy LLC likely has responsive information to the Subpoena Duces Tecum.
10. Two copies of the subpoena, along with this statement and the required notices and a fee of \$14.45 to Onvoy LLC is being remitted to send the documents Registered Mail to the respondent.
