
1 The Motion for Temporary Restraining Order filed by Petitioner San Franciscans for Balanced  
2 and Livable Communities, came on regularly for hearing. Having considered the written and oral  
3 arguments of counsel for the parties, and good cause appearing, IT IS ORDERED THAT:

4 Petitioner San Franciscans for Balanced and Livable Communities' Application for Temporary  
5 Restraining Order is GRANTED.

6 Respondents the Regents of the University of California, the University of California, the  
7 University of California, San Francisco, Michael V. Drake, in his capacity as President of the University  
8 of California, and Sam Hawgood, in his capacity as Chancellor of the University of California, San  
9 Francisco, are prohibited from engaging in any construction or demolition activities pursuant to the  
10 Comprehensive Parnassus Heights Plan ("CPHP"), the Long Range Development Plan Amendment #7,  
11 and Amendment #2 to the Physical Design Framework ("CPHP") that relate to the execution of plans to  
12 remove the Zackheim murals from their present location in UC Hall/Toland Hall until the court makes a  
13 ruling on Petitioner's Motion for Preliminary Injunction set for hearing on September 16, 2021.
