4 Petitioners' Southern Christian Leadership Conference of Southern California (the "SCLC-
5 SC") and Pastor William D. Smart, Joy Atkinson, Mary Lee, Kwame Cooper and Harry McElroy
6 (collectively, "League of Registered Voters of District 10") Application for an Order to Show Cause
7 re Preliminary Injunction (the "Application") came on for hearing before this Court on February 24,
8 2022 at 8:30 am. Having considered the Application together with the papers on file, as well as any
9 oral argument of counsel, for good cause showing, the Court hereby GRANTS Petitioners'
10 Application.

11 YOU ARE HEREBY ORDERED to appear on March 17, 2022 at
12 1230 pm in Department 82 of this Court located at 111 N. Hill St., Los Angeles,
13 California 90012, to show cause why a preliminary injunction should not be issued as follows:

14 ~~1. Ordering Respondents to vacate Councilmember Mark Ridley Thomas's~~

16 ~~2. Enjoining Respondents from appointing a "temporary" replacement for~~
17 ~~Councilmember Mark Ridley Thomas.~~

18 Ordering Respondents to vacate the appointment of Mr. Wesson to "temporarily" fill
19 Councilmember Mark Ridley Thomas's seat representing District 10 and barring
20 Respondents from seating him on the Council.
