Dear Speaker Vos:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”) hereby transmits a subpoena that compels you to appear for a deposition on September 26, 2022.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations.

The Select Committee has tremendous respect for the roles and responsibilities of federal, state, and local elected officials. At the same time, we have a solemn responsibility to investigate fully the facts and circumstances of these events.

The Select Committee’s investigation has revealed you have information relevant to its inquiry. Specifically, it has been publicly reported that in July 2022, you received a telephone call from former President Trump in which Mr. Trump asked you to take measures to change the result of the 2020 Presidential election in Wisconsin.¹ The call was apparently in response to a ruling of the Wisconsin Supreme Court in early July barring the use of drop-off boxes outside election offices for absentee ballots in future elections. After you reportedly told Mr. Trump that what he was requesting is not allowed under the Wisconsin constitution, Mr. Trump posted derogatory statements about you on Truth Social and endorsed your challenger in the 2022 Republican primary. The circumstances and details regarding your interactions with former President Trump related to the 2020 election are relevant to the Select Committee’s investigation and proposed recommendations.
