
**STATE'S MOTION TO SPECIALLY SET TRIAL**

COMES NOW, the State of Georgia, through Fulton County District Attorney Fani T. Willis, and respectfully requests that this Court specially set the trial in this case to commence for all 19 defendants on October 23, 2023.

On August 14, 2023, the Fulton County Grand Jury returned a true bill of indictment against Defendant Kenneth John Chesebro, among others, for various non-capital felonies. The term of court in which this Indictment was returned was the July-August, 2023 term of the Superior Court of Fulton County, Atlanta Judicial Circuit. *See* O.C.G.A. § 15-6-3(3). Defendant Kenneth John Chesebro filed on August 23, 2023 a “DEMAND FOR SPEEDY TRIAL.”

Without waiving any objection as to the sufficiency of Defendant Kenneth John Chesebro's filing, the State requests that this Court specially set the trial in this case to commence on October 23, 2023, which falls within the term of the "next succeeding regular court term" after the July-August, 2023 term of the Superior Court of Fulton County, Atlanta Judicial Circuit, as contemplated by


