CRIMINAL COMPLAINT

The Defendants above named having committed the crimes of MURDER (SECOND DEGREE) (Category A Felony - NRS 200.010, 200.030.2 - NOC 50010) and CONSPIRACY TO COMMIT BATTERY RESULTING IN SUBSTANTIAL BODILY HARM (Gross Misdemeanor - NRS 200.481, 199.480 - NOC 58407), in the manner following, to wit: That the said Defendants, on or about the 1st day of November, 2023, at and within the County of Clark, State of Nevada,

COUNT 1 - MURDER (SECOND DEGREE)

did willfully, unlawfully, feloniously, and with malice aforethought, kill J.L., a human being, by repeatedly striking and/or kicking J.L. on the head and/or body, the Defendant(s) being criminally liable under one or more of the following principles of criminal liability, to wit: (1) by directly committing this crime; and/or (2) by aiding or abetting in the commission of this crime, with the intent that this crime be committed, by counseling, encouraging, hiring, commanding, inducing and/or otherwise procuring the other to commit the crime; and/or (3) pursuant to a conspiracy to commit this crime, with the intent that this crime be committed, Defendants and/or unknown individuals aiding or abetting and/or conspiring by Defendants and/or unknown individuals acting in concert throughout.

1 COUNT 2 - CONSPIRACY TO COMMIT BATTERY RESULTING IN SUBSTANTIAL
2 BODILY HARM

3 did meet with each other and/or unknown individuals and between themselves, and
4 each of them with the other, willfully and unlawfully conspire and agree to commit a crime,
5 to-wit: Battery Resulting in Substantial Bodily Harm, and in furtherance of said conspiracy,
6 Defendants and/or unknown individuals did repeatedly strike and/or kick J.L. on the head
7 and/or body, resulting in substantial bodily harm to J.L.

8 All of which is contrary to the form, force and effect of Statutes in such cases made and
9 provided and against the peace and dignity of the State of Nevada. Said Complainant makes
10 this declaration subject to the penalty of perjury.
