This week the Justice Department [accused Apple trying to create a monopoly on smartphone markets](#).

In a federal lawsuit, the government says the company imposed contractual restrictions on developers, undermined apps and limited functionality with non-Apple products. Attorney General Merrick Garland even flagged the dreaded green bubble that iPhone users see when texting Android-using pals. [[Nolan Stout](#)]

Apple said the DOJ's 88-page lawsuit was "wrong on the facts and the law" and would "hinder our ability to create the kind of technology people expect from Apple."

The suit — which comes on the heels of EU laws [requiring Apple to allow](#) European users to download apps from outside its app store — summed up its criticism of Apple in a 2022 quote from CEO Tim Cook, who was asked whether Apple would fix iPhone-to-Android messaging.

The questioner complained, "I can't send my mom certain videos," to which Cook replied: "Buy your mom an iPhone."

Hours after the Supreme Court [said Texas could enforce](#) its new state deportation law, the Fifth Circuit Court of Appeals [blocked the law again](#) in a late-night order. ICYMI: New cases and rulings on our radar

» **Boston bomber jury bias:** BOSTON — The First Circuit [ordered the trial judge presiding](#) over the case of Dzhokhar Tsarnaev, the Boston Marathon bomber, to investigate whether jury bias was at play during the penalty phase. The panel notes that this will only affect whether he faces the death penalty, and that Tsarnaev will spend the rest of his life in prison regardless of the outcome of the investigation.

» **Court OKs Cali assault rifle ban:** SANTA ANA, Calif. — A federal court in California [upheld the state's ban on assault rifles](#) under the Supreme Court's test established in *Bruen v. New York*. The law has properly “singled out a subset of firearms” that are “dangerous and unusual weapons,” the court concludes.

» **Illicit reptile house:** BOSTON — The Massachusetts Court of Appeals [upheld a cease-and-desist that was issued against a homeowner](#) who runs a reptile breeding facility in his basement, in which he keeps bearded dragons, turtles and insects that are fed to the reptiles. The animals are not agricultural ones, bearded dragons are not customary pets, and even if turtles are customary pets, keeping 60 is not customary — so the zoning authority’s order was proper.
