The undersigned prosecutor for said County, hereby informs the Court that:

Count 1: SECOND DEGREE RECKLESS HOMICIDE, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Tuesday, June 5, 2018, in the City of Kenosha, Kenosha County, Wisconsin, did recklessly cause the death of another human being, specifically Randall P. Volar III, contrary to sec. 940.06(1), 939.50(3)(d), 939.63(1)(b) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while using a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

Count 2: OPERATING A MOTOR VEHICLE WITHOUT OWNER'S CONSENT

The above-named defendant on or about Tuesday, June 5, 2018, in the City of Kenosha, Kenosha County, Wisconsin, did intentionally take and drive a vehicle, a BMW, without the consent of the owner, Randall P. Volar III, contrary to sec. 943.23(2), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 3: ARSON OF BUILDING

The above-named defendant on or about Tuesday, June 5, 2018, in the City of Kenosha, Kenosha County, Wisconsin, by means of fire, did intentionally damage the building of Randall P. Volar III, without that person's consent, contrary to sec. 943.02(1)(a), 939.50(3)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

Count 4: FELONY BAIL JUMPING

The above-named defendant on or about Tuesday, June 5, 2018, in the City of Kenosha, Kenosha County, Wisconsin, having been charged with a felony in Milwaukee County Case 17CF3948 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of her bond, specifically by committing an additional crime, contrary to sec. 946.49(1)(b), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon

conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 5: POSSESSION OF A FIREARM BY A FELON

The above-named defendant on or about Tuesday, June 5, 2018, in the City of Kenosha, Kenosha County, Wisconsin, did possess a firearm, having been convicted of a felony in this state, contrary to sec. 941.29(1m)(a), 939.50(3)(g) Wis. Stats., a Class G Felony, and upon conviction may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.
