In a mostly balmy week in Manhattan, [Donald Trump's criminal trial](#) was all Stormy Daniels as the former adult film actress testified about her long-rumored sexual encounter with the former president.

Daniels testified that [she and Trump had sex in 2006](#), months after his youngest son's birth, after meeting at a Lake Tahoe celebrity golf tournament. Prosecutors accuse Trump of [falsifying business records](#) in order to pay Daniels to keep the story quiet a decade later, during his first run for president.

Trump's lawyers [sought to discredit Daniels](#) on cross-examination, at one point asking her, "You have a lot of experience in making phony stories about sex appear to be real, right?"

"That's not how I would put it," Daniels said in reply. "The sex in those films, it's very much real, just like what happened to me in that room."

#### New rulings on our radar

» **Southern District of Texas:** A law firm [may proceed](#) with claims against a lawyer referral service it says diverted prospective clients by buying the top search result position in Google searches of the law firm's business name and other marks.

» **San Francisco Superior Court:** Verizon, AT&T and T-Mobile [will pay](#) more than \$10 million to states that sued them over misleading ads, including for "unlimited" data plans.

» **Alabama Supreme Court:** The court [will not rehear](#) the IVF case it considered earlier this year regarding whether frozen embryos have the same state protections as children.

» **Southern District of California:** A class settlement gets [preliminary approval](#) in an antitrust lawsuit between food preparers and big tuna companies like StarKist and Chicken of the Sea.
