AMENDED JUDGMENT

THIS CAUSE is before the Court following the Jury's verdict returned after trial (ECF No. 153), the Court's March 31, 2023 Order (ECF No. 177), and the Court's Findings of Fact and Conclusions of Law entered on June 30, 2023 (ECF No. 180), regarding Defendant Roberto Guillermo Bravo's Renewed Motion for Judgment as a Matter of Law or, Alternatively, Motion

for New Trial (ECF No. 162) and the issue of equitable tolling. Pursuant to Federal Rule of Civil Procedure 58, it is hereby

ORDERED AND ADJUDGED that

1. Judgment is **ENTERED** in favor of Plaintiff RAQUEL CAMPS, in her capacity as the personal representative of the ESTATE OF ALBERTO CAMPS, in the amount of ONE MILLION DOLLARS (\$1,000,000.00) in compensatory damages and THREE MILLION DOLLARS (\$3,000,000.00) in punitive damages, against Defendant ROBERTO GUILLERMO BRAVO, for which sum let execution issue forthwith.

2. The claims asserted by Plaintiff EDUARDO CAPPELLO, in his individual capacity, and in his capacity as the personal representative of the ESTATE OF EDUARDO CAPPELLO, are **DISMISSED**, as barred by the statute of limitations.

3. Judgment is **ENTERED** in favor of Plaintiff ALICIA KRUEGER, in her individual capacity, and in her capacity as the personal representative of the ESTATE OF RUBEN BONET, in the amount of FOUR MILLION FIVE HUNDRED THOUSAND DOLLARS (\$4,500,000.00) in compensatory damages and THREE MILLION DOLLARS (\$3,000,000.00) in punitive damages, against Defendant ROBERTO GUILLERMO BRAVO, for which sum let execution issue forthwith.

4. Judgment is **ENTERED** in favor of Plaintiff MARCELA SANTUCHO, in her individual capacity, and in her capacity as the personal representative of the ESTATE OF ANA MARÍA VILLARREAL DE SANTUCHO, in the amount of SIX MILLION FIVE HUNDRED THOUSAND DOLLARS (\$6,500,000.00) in compensatory damages and THREE MILLION DOLLARS (\$3,000,000.00) in punitive damages, against Defendant ROBERTO GUILLERMO BRAVO, for which sum let execution issue forthwith.

5. The Court directs the Clerk to **CLOSE** this case.
